REPORT OF INTERVIEW

With Donna Shea, on November 5, 1991
at 1205 Hours at 60 Rodhes Circle,
Hingham, MA, by Special Agents
Thomas D'Ambrosio and Dennis Leahy,
Bureau of Alcohol, Tobacco and Firearms
Ms. Shea states as follows:

Ms. Shea said that Al Trinkler was gay and that Trinkler was doing cocaine and young boys. Mr. Shea also said that Trinkler, her and her husband had a business by the name of AWT Associates, and the AWT was in the communications business of installing satellite dishes etc.

Ms. Shea said that Trinkler went to Wentworth and was very smart at mechanical and engineering.

Ms. Shea said that Trinkler stole checks from the business to buy coke. Ms. Shea said that Rich Brown, of 35 Arnold Road; Quincy, knows where Trinkler is and that Brown's beeper # is 328-3772. Ms. Shea also said that they had another company called Race Inc., and that Brown also had worked at Cambridge Electric Trains.

Ms. Shea also said that Trinkler also stood to inherit 100K from his family and may have the money now. Ms. Shea said that Trinkler frequented the Blue Hills and rest area's, picking up young 14 - 15 year old gays. Ms. Shea said that Trinkler lived with Bob Craig of Milton for 3 years. Ms. Shea said that Trinkler has a brother David Wallace of Randolph, MA, telephone 961-2665.

Ms. Shea also said that Trinkler "rigged" up Jack Coyle's stereo so that when Coyle brought back gay partners for sex, Trinkler could listen to their conversations and sex acts.

Ms. Shea said that Trinkler did the remote control bombing in Quincy and that Trinkler used a remote control unit from a car to do the bombing,

Ms. Shea said that a lot of gays hung out at the Randolph County Club.

Ms. Shea said that John DiStasio was Rich's best friend.

Ms. Shea also said that a Michael Cody was a sex partner of Trinkler and that Cody stole 1 oz. of coke from Trinkler. Ms. Shea said that Cody was in law school at the present time,
