about 15 years ago you interviewed me from
the Plymouth county Jail. The Tape Later became
evidence which sent myself and ALFRED Trankler
to prison for life and 15 years, the latter being
my sentence.

However I think ITS BEEN a little too long
in telling you the truth. The Truth of all my
lies. But dont worry, this time theres PROOF to
support that I had to be LYING. which IS good
for me and you. you see son Hoping you
will have a reporters dignity to stand up and
report the truth. The truth makes a bigger splash
when so much wrong has been committed.

None of my statement that day so long ago
was truthful. IT was all lies. Lies for a
mentally ill young man seeking attention.

The IDEA of a surprise was fed to me by agent
JEFF Kark and your interview was the IDEA of
former Prosecutor Paul Kelly. I did not purchase
anything at radio shack, ALFRED Trankler and I knew
each other less than eight hours, we never discussed
family or anything outside of the gay scene and
rides I seeked from him home after missing
the red line train home.

The Boston Police I Believe were on the right track while they investigated my father. He had mob ties, gambling debts, enemies.

So I will ask you Ms. Marinella, why would the ATF produce a fraudulent Radio Shack receipt? especially if they thought we were truly guilty. I'll give you some supposition. The ATF needed their own positive publicity after Waco and Ruby Ridge.

So I enclose to you an affidavit from the Terrence Caperton's General Counsel, attesting to the fact that nothing on the Radio Shack receipt except the address and store #, is correct. None of the items I claimed to purchase in our interview even existed, even the receipt # is bogus.

So why would the ATF produce a fraudulent receipt and perjured testimony from an immigrant radio shack ~~employee~~ clerk? I'll tell you why. Because there was no evidence against us, the entire case is based upon lies.

So I'm asking you to help bring real justice to Terrence Hanley and Francis Foley. Convicting two innocent men isn't justice. I encourage you to reinvestigate. I offer you to visit the web site AlfredTranklerInnocent.org which has many other pieces of interesting data and inconclusive evidence including letters from

I'VE HAD ALL THE ATTENTION, NEGATIVE ATTENTION MY LIES CAUSED, MY LIES ENCOURAGED WITHIN THE JUSTICE SYSTEM.

WHAT IS ETHICAL? SOME SAY THAT THAT INTERVIEW MADE YOU CORRECT. SO, WOULD BREAKING THIS STORY LESSEN IT OR STRAIGHTEN YOUR RESOLVE TO TELL YOUR AUDIENCE THE TRUTH OR TO KEEP THEM IN THE DARK. IT MAY BE AN OLD STORY BUT LIKE SALVATI, EVEN A MAN WHO SPENT 30 YEARS IN PRISON FOR A CRIME THE FEDS KNEW HE DIDN'T COMMIT, DESERVES JUSTICE AT THE END

I CAN ONLY HOPE, FOR THE SAKE OF ALFRED STENKLER, AN INNOCENT MAN, AND TWO POLICE OFFICERS, YOU WILL HELP SEE JUSTICE SERVED. AS FOR MYSELF. I CAN'T RECAPTURE MY YOUTH. MY LOST TIME WERE CAUSED BY MY MENTAL INSTABILITY, IN LIES.
