Sir,

My name is Thomas SHAY. I am one of two men whom was wrongfully convicted of conspiring to build a Bomb which later killed a Boston Police officer and injured a second officer.

Sir,

at the time of the offense, it is my honest belief that the Boston Police were on the right track in their investigation of my father Thomas L. SHAY. He had mob ties, gambling debts and actually became paranoid of bombs of all things prior to the explosion before one attached under his car.
