Dear Senator Kerry:

If you recall, I had written to your office on 14 December, 2009, discussing my case of wrongful conviction and the recent discovery of evidence that the government had withheld from my trial counsel and the request for a reinvestigation of my case. I also discussed my suspicious sudden transfer from Federal Medical Center Devens to United States Penitentiary Tucson.

At the time I was concerned that I was being transferred, 1, to interfere with my then appeal in the First Circuit, and 2, to a facility where I would not receive the medical care for my heart condition and was trying to get the transfer cancelled, I have an implanted pacemaker.

Since then my stepfather, John D. Wallace, passed away from the effects of leukemia and pneumonia, and, as I was afraid, due to this transfer, I was never able to see my stepfather again, he passed in December of 2009.

On 19 February, 2010, Scott Dodrill, the Assistant Director of the Bureau of Prisons, wrote your office stating, "the Bureau's Office of Medical Designation and Transportation personnel received a non-medical transfer request from FMC

Devens. Prior to having his original sentence of life being reinstated, Mr. Trenkler was considered to be a low security level offender. Due to the change in his sentence he became a high security level offender and was no longer appropriate for placement at FMC Devens. Accordingly, he was approved by the Chief of Health Programs for a transfer and is pending transfer to a facility that is commensurate with his security, safety, programming and health care needs."

First of all, I was, in fact, placed on a medical transfer to USP Tucson. Second, by BOP definition and the Devens program statement, FMC Devens, an administrative facility, houses all custody level including pretrial and general population as well as medical needs inmates, from low, to high custody. In fact, not only are there inmates currently at FMC Devens with life sentences, there are inmates with life sentences being transferred from Tucson to FMC Devens. Third, since my arrival here at USP Tucson on 11 February, 2010, I have received no medical attention concerning my pacemaker, I have missed three quarterly appointments and have not had my pacemaker checked since October of 2009. I had been told at University Massachusetts Medical Center in Worcester that I had to have monitoring every three months, twice by phone and twice at a hospital for a general check up, EKG and recalibration. I have spoken to the medical staff here on a weekly basis and been assured that I will receive proper care, however, to date, this has not occurred.

Not only am I more than 2000 miles out side of my region,

I have no family in Arizona and cannot adequately maintain family and community ties, a situation that does not comport with the mission statement of the BOP.

This is all compounded by the fact that I am an innocent man fighting for the truth to come out, I am constantly fighting the courts to listen to my claims of malfeasance by government prosecutors withholding of exculpatory evidence from my trial counsel, a no no under federal rules both local and system wide.

Even the Boston Police saw that there was something wrong with this case and requested a reinvestigation, however, US Attorney Ortiz from the Boston office stepped in and quashed the whole idea.

Senator Kerry, there is something going on with this case when the government turns a blind eye to the discoveries of prosecutorial misconduct and the Boston Police request for another look at this case. My transfer across the country was simply a move to separate me from access to the media, investigators, local law enforcement, and my remaining family, friends and supporters.

At this time, I appeal to you to help me get the same medical attention I received at Devens and to request that the wheels be set in motion for a proper reinvestigation of this case to be conducted to right the wrongs that have gone uncorrected for far too long.


As for my location of incarceration, that can remain on the back burner as it were, I am in the middle of more court
