THE DAY THE BOMB EXPLODED HEINZ SR WAS INTERVIEWED BY TWO DIFFERENT TEAMS THEN BY A FEW DIFFERENT DETECTIVES. A DAY LATER THEN BY THE ATF ON LATER DATES

THE FIRST TEAM BISHOP MESSIA INTERVIEWED SR. SR STATES THAT ON ^{SUNDAY} ~~SAUNDAY~~ 10-27 AT 11:45PM SR FIRST OBSERVED THE BOMB (DOES NOT STATE BOTTOMING OUT OR SIGHTING BOMB)

THEN ON MONDAY MORNING SR DROVE HIS BUICK OUT OF THE DRIVEWAY AND HEARD A SCRAPE UNDER HIS CAR. HE GOT OUT OF THE CAR AND OBSERVED THE ARTICLE "AGAIN", PICKED IT UP AND EXAMINED IT THEN THREW IT AGAINST HIS HOUSE. HE THEN WENT INSIDE HIS HOUSE. HE HAD SECOND THOUGHTS WENT OUTSIDE AND THREW IT UNDER THE FRONT OF HIS CAR (I THOUGHT HE JUST MOVED CAR TO STREET). HE SAYS THAT HE WENT TO ASK SOME MECHANICS THAT HE KNEW ABOUT THIS ARTICLE THEN DECIDES TO CALL THE POLICE. (DOES NOT TOUCH BOMB)

HE THEN TELLS BISHOP/MESSIA THAT ON SUNDAY 10-27 HE LEFT HIS HOUSE AT 11:30 AM AND DROVE HIS BUICK TO MALDEN, CHELSEA SOLDIER'S HOME, THEN WENT TO CASTLE ISLAND THEN TO HIS AUNT'S HOUSE HAZEL HAYES 1024 MORTON ST DORCHESTER (HE LATER TELLS O'NEILL/THOMAS/FOGERTY THAT HE USED HIS NEIGHBOUR'S MAZDA ON SUNDAY.)

HOUR TO LOOK AT A CAR TO REPAIR, THEN HE GOES TO THE
CHERSEA MARVEL HOME TO VISIT HIS UNCLE, THEN HE WENT TO
THE DOUGHBOY DONUT SHOP, THEN WENT TO CASTLE ISLAND
AND MTE, THEN HE TRAVELS TO HIS AUNT'S HOUSE ON MORTON
ST IN DORCHESTER FOR 1/2 HOUR AND RETURNS TO EASTBOURNE
STREET AT 11-11:45^{AM}. WHEN HE ARRIVED MARY'S CAR WAS
IN FRONT OF THE HOUSE SO HE BACKED HIS CAR INTO
THE DRIVEWAY AND HEARD WHAT SOUNDED LIKE BOTTOMING
OUT. HE GETS OUT OF THE HOUSE CAR LOOKS AROUND AND
