ON 7/22/86 AT APPROX 1256 HRS - THIS WRITER WAS DISPATCHED TO THE REAR OF J.L. PENNY, FRT EDDY RD, CONCORD TO ASSIST OFF MOONEY W/ TWO JUVENILES WHO HAD FLED IN THE WOODS. SUBSEQUENT TO THE ABOVE OFF MOONEY EXITED THE WOODS W/ TWO JUVENILES. THIS WRITER ASKED ONE OF THE JUVENILES (THOMAS SHAY) WHAT IF ANYTHING HE KNEW ABOUT THE OTHER JUVENILES (BUZZELLS) SNEAKERS. HE ADVISED THAT BUZZELL (REFERING TO HIM AS JJ) HAD TAKEN THEM FROM BRADLEES DEPT STORE ALONG W/ HIS SHIRT. HE ADVISED JJ WENT IN W/ STOCKING FEET AND LEFT HIS OWN SHIRT SOMEWHERE IN BRADLEES. THIS WRITER ASKED SHAY IF HE'D BE WILLING TO GO TO BRADLEES TO POINT OUT THE SHIRT LEFT BEHIND AND HE AGREED.
