NOTE 1) OF THE 9 EXIS CASES IN THE 6-1-93 REPORT, 7 WERE REMOTE CONTROL CASES. OUT OF 79-91 THE ATF REPORTS 147 TOTAL REMOTE CONTROL DEVICES. THIS CANNOT BE CONSIDERED AN ISOLATED CASE.

NOTE 2) OUT OF THE 9 EXIS CASES, THE ONLY TWO DEVICES THAT LIST THE USE OF SOLDER ARE THE QUINCY CASE - 86 AND THE HORRIDGE 14 CASE - 87. IN THE 91 CASE THIS DOES NOT EVEN MATCH - SINCE INSPECTION SHOWS WIRES WERE TWISTED AND TAPED.

NOTE 3) IN THE ORIGINAL 6-14 DEC 92 EXIS REPORT IT WAS ENTERED THAT THE 86 DEVICE CONTAINED A TOGGLE SWITCH THAT WAS FROM RADIO SHACK AND DREW A MATCH TO SHAY'S 91 DEVICE WHERE A TOGGLE SWITCH WAS PURCHASED FROM RADIO SHACK 18 OCT 91. IN THE SUBSEQUENT EXIS REPORT, 1 JUN 93, THE 86 DEVICE IS NOW LISTED WITH THE DPDT AS BEING FROM AN UNKNOWN MANUFACTURER. HMMMMMM! AN OBVIOUS CHEAT OF THE SYSTEM

NOTE 4) OUT OF 9 DEVICES IN THE 1 JUN 93 EXIS REPORT, 9 DEVICES CONTAINED MAGNETS. ATF DREW A MATCH BETWEEN MY ROUND SPEAKER MAGNET AND SHAY'S ROUND BALANCE MAGNETS WHICH ARE NEITHER SIMILAR IN DESIGN OR MATERIALS - HOW CAN THIS BE CONSIDERED A MATCH. IT SEEMS THAT THE USE OF MAGNETS IS GENERIC IN NATURE.

NOTE 5) THE ATF IN THEIR INFINITE WISDOMS LISTS MY ONE MAGNET TWICE, 1) ROUND SPEAKER 2) SPEAKER ROUND. ON THE SECOND MAGNET ENTRY SIMPLY THE HEADWG MG IS UNDERLINED AND PURPORTED TO BE ANOTHER MATCH. THE SECOND ENTRY IS CHEATING THE SYSTEM.

NOTE 6) OF THE 9 DEVICES, 5 USED FILAMENT OR DUCT TAPE. THE 86 DEVICE USED 2" WIDTH TAPE, THE 91 DEVICE USED 1 9/16" WIDTH TAPE. DUCT TAPE IS NOT RARE TO HOME + BUSINESS AND SEEMS TO BE OVER 50% FAVORITE OUT OF THE 9 BOMBS IN THE 1 JUN 93 EXIS REPORT.

NOTE 7) 5 OUT OF 9 DEVICES LISTED USED FUTABA REMOTE CONTROL SERVO UNITS. 1 OUT OF 9 USED A KO PROP SERVO UNIT, AND ONLY 1 ~~UNIT~~ ^{DEVICE} USED A NON SERVO REMOTE CONTROL - THE 86 DEVICE, THE 86 DEVICE SEEMS TO BE LIKE NO OTHER OF THE 9 DEVICES LISTED. THIS IS NOT A MATCH

1) DATES ON DURACELL BATTERIES - I CONSTANTLY BUY DURACELL AA AND AAA BATTERIES FOR MY PAGER COMPANY. I HAD BOUGHT THE PARTICULAR AA BATTERIES THAT THE ATF HAD TAKEN FROM ME, DATED 96, ALMOST AT THE BEGINNING OF 1991. THE BATTERIES IN THE ROBLINDAKE DEVICE WERE DATED 94, WHICH MEANS THAT EITHER THESE BATTERIES WERE OLD AND SOME PERSON HAD THEM FOR A CONSIDERABLE AMOUNT OF TIME OR THE STORE WHERE THEY WERE PURCHASED DOES NOT ROTATE THEIR STOCK OR DOES NOT SELL VERY MANY AA DURACELL BATTERIES,

2) WE MUST FIND OUT FROM FUTABA WHAT THE CURRENT DRAW OF THE FUTABA RECEIVER IS AND DETERMINE HOW LONG BATTERIES ON STANDBY WOULD LAST. (152)

3) SINCE THERE WAS NO SAFETY SWITCH ON THIS DEVICE, AND SUPPOSEDLY IT WAS AFFIXED TO SHAM'S VEHICLE ON SATURDAY THE 26TH, SHAM SUPPOSEDLY TRAVELED THROUGHOUT THE BOSTON AREA PASSING MANY POWERFUL RF SOURCES, SUCH AS THE PROVIDENTIAL BUILDING WHICH PUTS OUT SIGNALS FROM 20 MHz TO 23 GHz AT A TOTAL POWER OUTPUT OF OVER 1 MILLION WATTS, PLUS THE HANCOCK FOR A TOTAL OUTPUT OF OVER 20 000 WATTS, THE ONE FINANCIAL BUILDING @ 7500 WATTS, ONE BOSTON PLACE OVER 50 000 WATTS ETC ETC ETC AND THE FACT THAT THIS DEVICE WAS SET OFF IN A RELATIVELY QUIET RF ZONE BY AN RF SOURCE TELLS ME THAT EITHER SHAM SR HAD JUST PLACED THIS DEVICE ON HIS VEHICLE AND A STRAY SIGNAL SET IT OFF OR IT WAS INTENTIONALLY SET OFF BY THE REMOTE CONTROL TRANSMITTER AT THE TIME SHAM SR CALLED THE POLICE - UPON THEIR ARRIVAL.

4) WE NEXT TO KNOW WHAT FREQUENCY THE FUTABA WAS SET TO OPERATE ON - COMBINED WITH WHAT BPD UNITS WERE PRESENT, WHAT BPD FREQUENCIES WERE BEING USED BY 1) MRAFT 2) MOBILE UNITS - MARKED 3) MOBILE UNITS UNMARKED 4) BOMB SQUAD 5) ANY OTHER MOBILE UNITS. IT WOULD BE EASY TO DETERMINE EITHER SIMULTANEOUSLY OR COMBINED WHAT WOULD CAUSE A STRONG SIGNAL CLOSE ENOUGH IN FREQUENCY TO CAUSE THE FUTABA REMOTE CONTROL TO ACTIVATE. ALSO - WHAT IS THE CODING- FORMAT OF THE FUTABA - WHAT CAUSES THE "HORN" TO ROTATE LEFT VS RIGHT. ANOTHER POSSIBILITY WOULD BE THAT THE POLICE RADIO WHICH USES ONE OF MANY POSSIBLE CODING FORMATS COULD HAVE SENT A CODE CLOSE ENOUGH TO THE FUTABA TO SET IT OFF.
