


I/O earlier in the evening (approx 1730hrs) at which time he asked officers if they were doing a stakeout for gays in the mens room. He further explained that approximately one week ago he had a problem with a couple of gays in the mens room and that later in the night he was beaten up by a couple of X gays who he supposedly called the cops on. Upon having this second contact with the subject I/O along with Ptlm Platt and MBTA Ptlm Cedrone conducted a warrant check at which time it was learned that there was a Quincy KKK Court warrant #89CR3247 for Larceny of a Motor Vehicle against Mr Shay. Mr Shay appeared very nervous while talking to officers. Subject was transported to MBTA Police HQ for processing. A complete search of BackBay Station proved negative for a device. Officers could not compile any evidence connecting Mr Shay to the Bomb Threat call. I/O to obtain a picture of Mr Shay when photo's are ready. Mr Shay appears to be an unstable subject, he stated to MBTA Police that he has attempted to commit suicide 8 times during the past. MBTA Police to advise I/O X of any new information they may receive on Mr Shay.

HE THEN WOULD BE CALM EXCITED AND STATED "I HAVE BEEN GIVEN A NOTE THAT I MUST READ TO YOU." 2 LBS OF EXPLOSIVES WITH A CMX TIMER WAS SET TO GO OFF AT 8:30 PM AT BACK BAY STATION" SUBJECT THEN HUNG UP. I THEN ADVISED BOSTON POLICE BOMB SQUAD, MBTA PD SGT LENAHAN. NYP INSPE AMICO #29 AND SGT WHITEHURST. K. NYP NEW YORK RADIO DESK FOR COMMAND CENTER OPT CANTY. AT 1844 HRS INU MARTINO ADVISED MBTA PD HAD 10/11/90 INCIDENTS ON OUTSTANDING WARRANTS. SUSPECT HAD BEEN ACTING SUSPICIOUS IN STATION. INU MARTINO ADVISED IF SUSPECT AGGRAVATED TO THE MBTA PD WOULD HAVE SUSPECT REPEAT STATEMENT TO 196 OVER TELEPHONE. 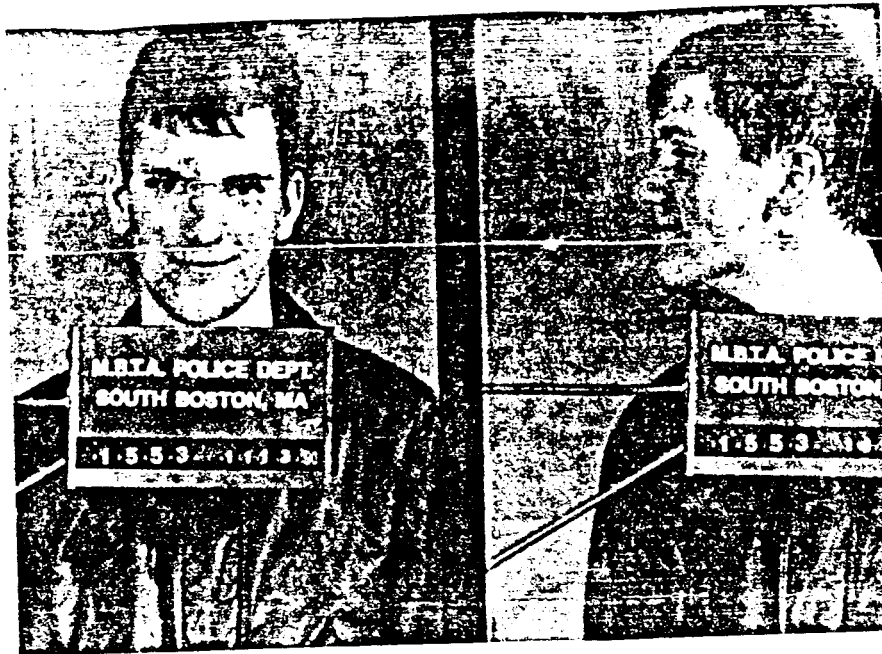
