TODAY - THURSDAY I COULD NOT GIVE JOHN CATES A RIDE TO WORK. I WENT TO THE 92 BROAD STREET OFFICE AT 7:00 TO GET MY TOOLS FOR THE DAYS OPERATION. ~~MURDAN CALLED~~ ~~ME AT THE OFFICE ABOUT 7:15 AND HELPED FINISH LOADING MY TOYOTA WITH MY TOOLS. NOW I THEN LEFT THE OFFICE~~ AND MET MURDAN AT THE CSM PARKING GARAGE ABOUT 7:30 7:45. MURDAN AND I WALKED OVER TO THE SECURITY DESK AND I SIGNED FOR THE ADMINISTRATION BUILDING KEY, MURDAN GAVE HIS NAME TO SECURITY FOR HIS BADGE AND I GAVE SECURITY THE NAMES OF DAVID PADDY AND PETE CATALDO. MURDAN AND I THEN WENT BACK TO THE PARKING GARAGE AND WAITED FOR DAVID PADDY AND PETE CATALDO TO ARRIVE. UPON THEIR ARRIVAL, THEY STOPPED AT THE PARKING GARAGE BOOTH AND SIGNED IN AND RECEIVED THEIR BADGES AND PAID \$3.00 FOR PARKING (AS MURDAN AND I HAD DONE). ~~WE~~ APPROX 8:00 AM. WE ALL GATHERED OUR TOOLS AND ENTERED THE ADMIN. BUILDING, BY WAY OF SECURITY ID CAMERA AND WERE BUZZED INTO THE BASEMENT AREA. THERE I HAD TO USE THE ADMIN KEY TO ACCESS THE ELEVATOR TO THE TOP FLOOR OF THE BUILDING. UPON ARRIVAL WE ALL STEPPED OFF THE ELEVATOR AND I OPENED THE ~~HEAVY~~ DOOR TO THE ROOF STAIRWAY WITH THE ADMIN KEY. AFTER NURDAN HAD THE BOXES OPEN, HE AND I MOVED THE DISHES INTO POSITION AND UNPACKED THE DISH HARDWARE AND STARTED TO ASSEMBLE THE DISHES. AROUND NOON TIME I CALLED DOMINO'S PIZZA AND INSTRUCTED THE DRIVER TO WAIT AT THE BOTTOM OF THE ADMINISTRATION BUILDING - THE DOMINOS DISPATCHER KNEW THE LOCATION FROM PREVIOUS DELIVERIES TO CSM & AND THAT HE WOULD HAVE TO WAIT FOR A FEW MINUTES SINCE WE WERE WORKING ON THE ROOF AND WOULD GO TO MEET HIM WHEN WE SAW HIM FROM THE ROOF. ABOUT 20 MINUTES LATER THE DOMINOS TRUCK ARRIVED AND I SENT NURDAN DOWN TO MEET IT. WHEN NURDAN CAME BACK UP TO THE ROOF HE TOLD ME THAT HE RAN DOWN THE STAIRWAY SINCE THE ELEVATOR WAS TAKING SO LONG. WE ALL ATE LUNCH AND CONTINUED WITH MOUNTING THE TWO DISHES AND TAKING APART THE BOXES. DURING THE DAY I TOOK PICTURES OF THE WORK AS IT PROGRESSED. WHEN WE WERE DONE FOR THE DAY, DESIGN SHOP LEFT THEN NURDAN LEFT ON HIS MOTOR CYCLE, I WENT TO THE SECURITY OFFICE AND RETURNED THE ADMINISTRATION ROOF KEY, I THEN WENT BACK TO THE OFFICE AND LEFT MY TOOLS. I CALLED JOHN CATES AT THE OFFICE AND HE INFORMED ME THAT HE WOULD BE OUT OF WORK AT 6 PM. I LEFT THE OFFICE AT AROUND 5:30 AND MET JOHN CATES AT 6:00 AT THE FLEET BANK ON BOYLSTON STREET - BOSTON. I BELIEVE THAT NIGHT JOHN AND I ATE AT PIZZERIA UNO. WE THEN LEFT UNO'S AND WENT TO LEICHERE ^{WEYMOUTH} AND I GOT THE REBATE ON MY NIKON CAMERA WHICH WAS PURCHASED ON 9/30/91. WE THEN WENT BACK TO 133 ATLANTIC AVE - QUINCY UNTIL THE FOLLOWING MORNING - WHEN I GAVE JOHN A RIDE TO WORK ON THE 18 TH
