7:15 AM JOHN CATES AND AL T LEAVE THE 133 ATLANTIC STREET RESIDENCE AND DRIVE DOWN TO PJ'S MINI MART TO GET CIGARETTES AND COFFEE. ABOUT 7:20-7:25 AM WE LEAVE PJ'S AND I DRIVE JOHN CATES TO ST JAMES STREET AND DROP JOHN OFF FOR WORK AT FLEET BANK. I THEN LEAVE ST JAMES STREET AND DRIVE TO THE 82 BROAD STREET WEYMOUTH OFFICE.
