DONNA SHEA INTERVIEW 5 NOV 91

→ DONNA'S FIRST STATEMENT "TRENKLER WAS DOING COCAINE AND YOUNG BOYS" IS NOT TRUE. DONNA SEEMED TO HAVE AN OBSESSION THAT WHOEVER I WAS SEEN WITH - I WAS HAVING SEX WITH. THIS WAS NOT THE CASE. SHE WAS ALSO CONVINCED THAT I USED COCAINE TO "GET" BOYS TO HAVE SEX WITH ME. AS AN EXAMPLE, I LIVED WITH BOB CRAIG FOR FOUR YEARS AND YES, I DID COCAINE WITH HIM BUT SEX WAS NOT PART OF OUR RELATIONSHIP - IT WAS PURELY A PLATONIC RELATIONSHIP AS IT WAS AND IS WITH ANDREW ROBSON, RICH MARSHALL AND BRIAN O'LEARY. TO THIS DAY, DONNA IS CONVINCED THAT I HAVE SEX WITH ALL OF MY FRIENDS. ONE OF HER FAMOUS SAYINGS IS "A GUY IS GAY UNTIL PROVEN STRAIGHT" I BELIEVE THAT PART OF HER OBSESSION COMES FROM THE FACT THAT HER HUSBAND AND I (JOHN SHEA) HAD A PHYSICAL RELATIONSHIP AROUND 1979-81 UNTIL DONNA MARRIED JOHN IN 1981. IT SEEMED AS IF SHE WAS TRYING TO COVER UP THE FACT THAT JOHN <sup>SHEA</sup> AND I HAD A RELATIONSHIP AND THAT SHE WOULD ALWAYS GO ~~OUT~~ OUT OF HER WAY TO ANNOUNCE THAT I WAS GAY AND THAT HER HUSBAND WAS TOTALLY NORMAL. SHE WOULD CONSTANTLY TRY TO ALIENATE MY FRIENDS FROM ME BY TELLING THEM I WAS GAY - THOUGH IT NEVER WORKED AND I HAVE ~~NEVER~~ <sup>SINCE</sup> NEVER LOST ANY FRIENDS. THIS ALWAYS SEEMED TO AGGRUVATE DONNA.

- THE STATEMENT DONNA MADE CONCERNING MY INHERITING 100K. I  
IN THE EARLY 80'S  
BELIEVE SOME TIME AROUND I HAD MENTIONED THE FACT THAT I HAD A  
TRUST FUND BUT NEVER GAVE IT A MONETARY VALUE. I HAD SAID THAT  
I HAD NO CONTROL OVER IT AND THAT SOME DAY IT WOULD BE WORTH

- THE STATEMENT ABOUT FREQUENTING THE BLUE HILLS AND REST AREAS  
PICKING UP 14-15 YEAR OLDS, FIRST OF ALL TO ACCESS THESE AREAS  
ONE WOULD NEED A CAR WHICH WOULD DICTATE THAT ONE WOULD  
HAVE TO BE AT LEAST 16 1/2 YEARS OLD. PLUS WHEN I WAS 23  
I WOULD HAVE BEEN SEEING PEOPLE ANYWHERE FROM 17 TO 30  
YEARS OLD. DONNA'S MEMORY OF ME THEN SEEMS TO BE MAINTAINED  
AT MY AGE NOW OF 36. I PROBABLY HAVE KEPT AWAY FROM  
DONNA AFTER THE 1986 INCIDENT AND MOST OF THE TIMES I DID SEE  
HER AFTER 86 WOULD BE WHEN SHE WOULD COME TO WHERE BOB  
CRAIG AND I LIVED JUST TO TRY AND TELL EVERYONE SHE COULD  
THAT I WAS GAY BECAUSE SHE WAS MAD THAT I DID NOT WANT HERSELF  
AND DONNA SHEA WORKING FOR ME.
