

REPORT OF INTERVIEW

With John Shea, on November 6, 1991,
at 2:00 P.M., at Plymouth County House of
Correction, Plymouth, Mass.,
by Special Agent John S. Paolillo and
Special Agent Henry J. Moniz Jr.,
Bureau of Alcohol, Tobacco, and Firearms.
Mr. Shea states as follows:

Shea said that he has been an inmate at the Plymouth County House of Correction since June 1991. He is being held for Attempted Murder, Kidnapping as well other charges stemming from a June 1991 incident. Shea's current address is 6 Rhodes Circle xxxxxxxx, MA. Shea is married and his wife's name is Donna.

Shea acknowledged that he knew Al Trenkler and stated that Trenkler lived in Quincy at the present time. Shea has known Trenkler for a number of years. They grew up down the street from one another in Milton. At the present time Shea has a grudge against Trenkler and has intensions of settling this problem when he released from prison. Shea alleges that Trenkler related the facts of Shea's June 1991 incident to the Television Program "Current Affair". According to Shea Trenkler made an appearance on the show which aired sometime in the summer of 1991. This prompted Shea to no longer trust Trenkler and turned his friendship towards him to hatred.

When asked about Trenkler's background Shea stated that Trenkler was an Electrical Engineer who has worked at various electrical supply stores around the Boston area. One store in particular, Atel, which is located in Dorchester is one electronics store where Trenkler has worked. Shea said that Trenkler use to steal electronics equipment out of there all the time. Shea further stated that Trenkler stored all this equipment until he needed its use. Shea said that Trenkler is a homosexual but did not indicate how long he has been one. Also, Trenkler allegedly has a bad cocaine habit and freebases coke almost daily. Trenkler could spend up to \$200 a day to satisfy his cocaine habit, according to Shea. Shea admitted to hearing about the incident in Quincy which involved his wife. He stated that his wife was questioned by Quincy Detectives. Shea did not admit that Al Trenkler was involved in the incident in any way.

Shea gave a description of where he believed Trenkler to be living at the present time. Subsequently it was determined that the address to his description was 207-209 Atlantic Ave, Quincy, Ma. Shea further stated that he has been to that location before and Trenkler lives in a basement apartment towards the front of the house. Shea volunteered the names of Mike Lacody (Quincy Ma.) and Richard Brown (Quincy, Ma) of two people who would most likely know of Trenkler's whereabouts. Mike Lacody is believed to be a homosexual, however, Richard Brown is not believed to be one. Shea indicated that he would mind us contacting his wife for more information concerning Trenkler and also he stated that he would further assist us if he could in any way.
