REPORT OF INTERVIEW

With Richard Kaczynski, [REDACTED] on November 26, 1991, at approximately 3:00 PM., by Special Agent Wayne Miller and Special Agent Jeff S. Kerr, Bureau of Alcohol, Tobacco and Firearms. Mr. Kaczynski stated as follows:

Mr. Kaczynski stated that he is employed by Parkway Auto Body, 303 Whiting Avenue, Dedham, Massachusetts, Tel. No. [REDACTED]. He stated that he on occasion drives the tow trucks for Parkway Towing, 8 Willow Street, West Roxbury, Massachusetts.

Kaczynski stated that on October 28, 1991 he was dispatched with tow truck (ramp tow) to 39 Eastbourne Street, Roslindale, Massachusetts to tow a vehicle. He stated that he was accompanied by John Wessel, an employee of Parkway Towing. He stated that Wessel soon departed the scene and that he remained to assist the Boston Police Department in towing which ever vehicle they requested.

Kaczynski stated that he was requested to lift a vehicle from 39 Eastbourne Street twice so that the vehicle could be searched for additional explosives. He stated that after a lengthy stay he was instructed to transport the vehicle in question to the South Boston Police Station. He stated that he complied with these instructions and then departed. He stated that he did not make any telephone calls relative to this tow.

Kaczynski stated that he is familiar with the Dedham Service Center

He stated that last year he went with Giammarco to a Tow Show in Chicopee, Massachusetts but other than that he had not spoken with him for approximately one year.

Kacyznski stated that an individual named Bobby Hadyia works at the Dedham Service Center as well as for Parkway Auto Body and Towing.
