Mrs. Joyce stated the following:

Mrs Joyce stated that she was home at the time of the bombing. She stated that she didn't notice anything suspicious or unusual during the weekend before the bombing or during the morning hours on the day of the bombing. She did state, however, that approximately one or two months prior to the bombing, she and her husband noticed a black car parked outside their home at 6:00 a.m. She stated that there were two white males sitting in the car at the time. She stated that when her husband went to put out the trash, the vehicle drove away. She further stated that when he went back into the house, the vehicle returned and continued to park outside their home. She stated that this made her husband nervous and that he called the police. By the time the police arrived however, the vehicle had left. She stated the vehicle was sporty looking and looked somewhat like a Charger. She also stated that the two white males looked as if they were in their twenties. She stated that while they were parked, one man left the car, walked up Westbourne St. and went partially down the driveway of her neighbor and then turned around and went back to the car. She stated that the other man then did the same thing. She also stated that her husband notice pornographic magazines in the front seat of the car.
