RICHARD BROWN INTERVIEW 20 NOVEMBER 91. @ 3:15 PM

- THE STATEMENT THAT HE HAD NO BANK ACCOUNT IS FALSE. HE (WITH WALLACE BROWN - RICH'S GRANDFATHER) HAD A JOINT ACCOUNT AT SHAWMUT BANK IN QUINCY MASS. RICHARD GORMLEY WAS AND STILL IS THE BANK MANAGER AND CAN ALSO VERIFY THAT RICH BROWN WAS WRITING CHECKS AGAINST A NEGATIVE BALANCE. ~~PROVIDE~~ DURING OCT, NOV. AND DEC 91
- THE STATEMENT "AL HAD TOLD HIM THAT HE HAD GIVEN SHAY A RIDE TO THE "T" ONE WEEKEND AND HE (BROWN) REMEMBERED SHAY (JR)" IS FALSE. I HAD SAID TO RICH AFTER HE HAD SAID TO ME HE REMEMBERED SHAY FROM ATEL THAT HE WAS WRONG, THAT I DID NOT MEET SHAY (JR) UNTIL JUNE OF 91 WHEN RICH HAD GIVEN JR A RIDE TO HIS FATHER'S HOUSE IN DORCHESTER.
- THE NEXT STATEMENT "THAT SHAY (JR) WAS A DRUGGIE" RICH BROWN MAY OR MAY NOT HAVE SAID THIS - I DON'T KNOW - AND I DON'T KNOW WHERE HE GOT THIS NOTION FROM BECAUSE AS FAR AS I KNEW SHAY (JR) DID NOT DO DRUGS (NEVER WITH ME).
- NEXT SENTENCE "AL WOULD PAY FOR SEX WITH YOUNGER MALES" IS TOTALLY UNFOUNDED. 1) I NEVER PAID FOR SEX WITH ANYONE AND 2) NEVER TOLD RICH ANY SUCH THING. I BELIEVE THIS COMES FROM DONNA SHEA.
- I DO TELL RICH BROWN THAT I MET SHAY HANGING AROUND WITH SOME FAMILIAR FACES THAT I HAD SEEN IN TOWN.
- THE STATEMENT ABOUT THE GLUE GUN. I HAD BROUGHT THE GLUE GUN AS WELL AS OTHER TOOLS TO THE OFFICE. RICH BROWN INTERVIEWS

IN REGARDS TO THE STATEMENT MADE BY RICH BROWN 12-4-91  
CONCERNING "A WRITTEN DEAL THROUGH AN ATTORNEY", I HAD SAID TO  
RICH BROWN IN RESPONSE TO HIS STATEMENT TO ME - "AL, IF YOU HAD  
ANYTHING TO DO WITH THIS OR KNOW ANYTHING, I'D MAKE A DEAL NOW  
NAIL SHAY BEFORE HE NAILS YOU." I SAID TO HIM, "I KNOW NOTHING  
ABOUT THIS CASE, I DON'T KNOW IF SHAY HAS ANYTHING TO DO  
WITH THIS CASE, BUT IF I DID THE ONLY WAY I'D MAKE A DEAL

THAT?" RICH SAID, "I DON'T KNOW, YOU JUST BETTER NOT. ALL I KNOW  
IS THAT I COULD SEE YOU DOING THAT JUST TO "GET" THAT MID."  
I SAID, "I'VE NEVER BEEN THAT DESPARATE, BESIDES, WHEN WOULD  
I HAVE HAD TIME, I'VE BEEN WITH YOU <sup>OR YOUR FRIENDS AT WORK</sup> ALMOST EVERY DAY FOR <sup>WEEKS</sup> MONTHS
