Mr. Brown said that his pager number was 532-3114 and that Al Trenkler's pager was 553-0778. Brown said that Trenkler has a boyfriend previously by the name of Brent Donahue and that Donahue worked for a landscaping company. Brown also said that Al carries telephone numbers in his wallet.

Brown also said that a Rob Destazio was an employee of ARCOM, and that Destazio lived at 285 Adams Street, Quincy, MA, telephone # 471-3596. Brown said that Destazio was on an ankle bracelet. Brown also said that he was 80% sure Shay (Jr.) was in the Store 24, across from his business and that Shay (Jr.) was friendly with an employee of Store 24, who was short with a beard. Brown also said that he had been in ATEL, Brookline St., Boston where Al had a room, about 10'x15' in size.
