Ms. Shay said that Tom Shay (Jr.) lives with her and at the time of the bombing Shay (Jr.) was home sleeping. Ms. Shay said that Shay (Jr.) was in New York and had returned for the civil suit disposition concerning his father's civil suit. Ms. Shay said that her son stayed with older men who were gay.

Ms. Shay said that Jr. had a young male friend, who did not drive and lived in Quincy. Ms. Shay said that Jr. had emotional problems and was always trying to get attention. Ms. Shay said that she was at a family Christening a week ago and spoke with Tom Shay (Sr.) and he (Sr.) said that this lawyer told him not to say anything and he would not say anything about the incident.

Ms. Shay said that Jr. passed out leaflets for the "Manray" (Club), 21 Brookline St., Cambridge, MA (884-0400), a gay bar, and was allowed in with no cover charge.

Ms. Shay said that Jr. wrote her a letter from jail in which he described his life as normal, the letter was fantasy according to Ms. Shay. Ms. Shay refused to show the letter or allow Special Agents Leahy or D'Ambrosio to read it.

Ms. Shay said that she has not lived with Tom Shay for about 12 years.

Ms. Shay said that her daughter was a cook in the Amtrack Building and that she worked for a jewelry store for 5 weeks in the same building until she was let go because of this incident.
