


DETAILS:  "Property Transmittal"  This report pertains to the ongoing investigation of a bombing incident which occurred on 10/28/91 in Roslindale, Massachusetts taking the life of one Boston Police Bomb Technician and critically wounding another.  On January 31, 1992 a federal search warrant for the premises at 133 Atlantic Street, Quincy, Massachusetts, the downstairs apartment, rented to one John Cates, was executed by ATF Special Agents Allan Offringa and Jeff S. Kerr and assisted by Boston Police Officers Brendan Craven and Edward O'Toole.  At approximately 7:40 AM., Michael Green, brother of landlord George Green, directed the search warrant team to the bottom floor apartment of 133 Atlantic Street. There Mr. Green entered said apartment and took control of one dog located within. At this time the interior of the apartment was photographed by Special Agent Offringa. Upon the completion of these photographs, the remainder of the search team entered the apartment.  At approximately 7:45 AM., George Green, owner of 133 Atlantic Street, signed an ATF consent search waiver form consenting to the search of all common areas within the structure as well as an unattached garage which is used by Green's brother Michael.  At approximately 7:50 AM. one Alfred W. Trenkler entered the downstairs common area of 133 Atlantic and requested an explanation as to why the apartment that he shares with John Cates was open and occupied by law

At this time Special Agent Kerr informed Trenkler of the circumstances. Trenkler requested that a briefcase which was located within the apartment be turned over to him prior to the search. At that time Special Agent Offringa began a search of the articles contained within the brief case. Officers Craven and O'Toole and Special Agent Kerr searched the apartment which consisted of a living room/sleeping area, closet, bathroom and kitchen area.

The following items were discovered and retained for evidentiary purposes:

1. One (1) black miniature speaker, approximately 7" x 3 1/2".
2. One (1) bottle of LePage's rubber cement
3. One (1) stick of crazy glue, (green, white and red) casing.
4. Eleven (11) pens.
5. Two (2) Radio Shack nine volt batteries, Three (3) Duracell AA batteries.
6. One (1) receipt from Sears for \$ 102.37, dated 9/27/91, One (1) receipt from Donna Shea for \$ 500.00, dated 12/9/91.
7. One (1) Hoover Type K, Part No. 43651-045 paper vacuum bag (used).
8. One (1) rubber banded bundle of checks (Shawmut Bank) in the name of Advanced Research Communications, signed by Richard Brown.
9. Paperwork to include three (3) notebooks, twelve (12) files and loose papers.
10. Two (2) photographs.

During the course of the search, Alfred Trenkler remained in the apartment or outside the apartment from approximately 7:50 AM. through 8:10 AM. Trenkler then departed. He returned to his apartment at approximately 11:50 AM. and remaining until the completion of the search, approximately 3:00 PM. Throughout the time that Trenkler was present at the apartment, he initiated and maintained dialogue with the search team.

At the conclusion of the search, a copy of the search warrant and inventory was left in the apartment. Trenkler secured the apartment.
