9. DETAILS:

This report pertains to ATF's investigation into the October 28, 1991 bombing which occurred in Roslindale, Massachusetts taking the life of Boston Police Department Bomb Technician Jeremiah Hurley and critically wounding Bomb Technician Francis Foley.

On February 10, 1992 Special Agents Thomas D'Ambrosio and Jeff S. Kerr interviewed Christopher W. Punis, DOB: 11/15/68, S.S # 0 Punis resides at ██████████.

Punis stated that he worked for a company called Greenview Landscape during the years 1987-1988. He stated that it was at that time that he met Alfred Trenkler who was employed by Greenview Landscape.

He stated that while working at Greenview Landscape, besides Trenkler he met fellow employees Richard Brown and Tim Page as well as owners Brent Donoghue and Richard Bender

Punis stated that he lived for a short time with Trenkler at 1211 Atlantic Street, Hull, Massachusetts.

Punis stated that he met Bob LNU, an individual that Trenkler lived with in Hull.

Punis stated that at one point during his friendship with Trenkler and subsequent to their mutual employment at Greenview Landscape, approximately 1989, Trenkler obtained employment with a company called ATEL. He stated that Trenkler got him some work as a carpenter. He stated that this work lasted approximately one year.

DETAILS (Continued)

Punis stated that Trenkler now has a business called ARCOMM. He stated that Trenkler's partners name is Richard Brown. He stated that Trenkler told him that Brown, often dipped into the business finances.

Punis stated that late December 1991 early January 1992, he was hired to do some work for ARCOMM. He stated that some of the work was at the Christian Science Center.

Punis stated that he was not aware of Trenkler being gay until recently.

Punis stated that he has never met Thomas A. Shay.

This investigation is continuing.
