9. DETAILS:

REPORT OF INTERVIEW

With Robb DiStasio on February 19, 1992, at approximately 5:00 p.m., at 285 Plain Street, Brockton, MA., by Special Agents Dennis P. Leahy and Sandra R. LaCourse, Bureau of Alcohol, Tobacco and Firearms

Robb DiStasio stated the following:

Robb DiStasio stated that he met Al Trenkler through Rich Brown. He stated that soon after Rich Brown had done some electrical work on his 68 convertible, Brown offered him (DiStasio) a job at Arcomm. He stated that he believed he started working at Arcomm in October of 91 because he remembered that it was around the time that he spent a night in jail on October 15, 1991. DiStasio stated that he only knew Al Trenkler as Rich Brown's business associate. He stated that he had talked to Trenkler regarding more hours and had also got his friend, Nurdan Cagdas, hired at Arcomm. DiStasio stated that he had heard Al was gay. He stated that he had also met Al's friend John who worked at a bank in Boston. He stated that his friend Scott Critcher, who is gay, had told him that Shay Jr. was gay. DiStasio was unable to identify Shay Jr. when shown a photographic line-up or a single photo of Shay Jr. He stated that he was never introduced to Shay Jr. nor had ever seen Shay Jr. with Trenkler. He stated that Trenkler had talked to him about the bombing and that he (Trenkler) had said that he didn't have anything to do it. He stated that Trenkler thought that Shay Jr. had placed the bomb. He also stated that Trenkler had admitted to knowing Shay Jr. and that they (Trenkler and Shay) had met through WBCN.
