REPORT OF INTERVIEW

With Jim Guy, on February 24, 1992, at Radio Shack, 197 Massachusetts Ave., Boston, Massachusetts, by Special Agent Sandra La Course and Special Agent Dennis Leahy, Bureau of Alcohol, Tobacco and Firearms, Boston Division. Mr. Guy states as follows:

Mr. Guy said that he was employed as a salesman on October 18, 1992, at the Radio Shack store located at 197 Mass. Ave., Boston, Massachusetts. Mr. Guy said that he could not identify anyone in either photo spread shown to him. Mr. Guy said that he did not know Thomas A. Shay or Al Trenkler when they were pointed out to him in the photo spreads. Mr. Guy said that he may see 50 to 75 people a day and does not remember seeing Shay (Jr) or Trenkler on October 18, 1992 or at any time.
