REPORT OF INTERVIEW

With Amy Lenar, on February 24, 1992, at 7:15 PM. at [REDACTED] by Special Agent Sandra LaCourse and Special Agent Jeff Kerr of the Bureau of Alcohol, Tobacco and Firearms. Mrs. Lenar stated the following:

Mrs. Lenar stated that her date of birth is January 3, 1965 and her social security number is [REDACTED]. She stated that she resides at [REDACTED]

Lenar stated that her natural father's name is Al Miller. She stated that she doesn't know who he is and that he was never married to her mother, Nancy Shay.

Lenar stated that her mother's first husband was Jerry Cargel. She stated that Cargel is the natural father to her sister Jeannie Maguire. She stated that Cargel and her mother divorced and that her mother married Thomas L. Shay. She stated that she considers Shay to be her only father and that he was a good father to her. She stated that he did on occasion discipline her and her siblings by use of a belt or spankings but that he (Shay) was never physically abusive to any of the children.

Lenar stated that Shay was physically abusive to her mother. She stated that this abusive behavior was not a result of alcohol or drug abuse and that she did not consider him to have a temper problem. She stated that the abuse was often in front of the children and that all of the children were affected in some way.

Lenar stated that at some point the (D.S.S) Department of Social Services intervened on behalf of the children, taking custody of them and placing them in foster homes. Lenar stated that shortly after the removal of the children from the parents custody, Nancy and Thomas were divorced. Lenar stated that she lived at a girlfriend's home for approximately one year and then returned to live with her mother. She stated that her brother Thomas A. Shay was sent to a boys boarding house which she believes was called The Nazareth and was located in Quincy, Massachusetts.

Lenar stated that when her brother Thomas was allowed to leave the boarding house he asked to live with his father and was allowed that request.

Lenar stated that on October 28, 1991 the night of the bombing, she was first notified of the incident by her sister Jeannie who telephoned her at work. She stated that she returned to her residence and watched the news report. She stated that she then went to her sister Jeannie's house and then the two of them went to their grandmother's (paternal) apartment in Roslindale.

Lenar stated that she was furious at her brother Thomas for making himself so visible throughout the early stages of the investigation. She stated that she asked her brother why he was doing interviews and that he informed her that it was to deflect the pressure away from the father.

Lenar stated that her brother Thomas was staying at their mother's house prior to and up to the day of the bombing incident. She stated that she believes her mother drove her brother Thomas to a bus terminal a few weeks ago. She stated that her brother had called her from San Francisco a couple of weeks ago. She stated that he is a very transient individual and that he could be any where in the country. She stated that she doesn't have a typical brother sister relationship with Thomas, so they never discussed his exact whereabouts or how he survives away from home.

Lenar stated that she does not believe her brother Thomas is gay though she witnessed his admission to the same on a television talk show "People are Talking." She stated that she believes that he says he is gay for attention and that he is always seeking attention. She stated that he received plenty of attention growing up and that she would consider him a sort of "Mommy's Boy." She stated that he is closest to their mother but that he is also very close to the father.

Lenar stated that she only met one of her brother's friends. She stated his name was Ralph. She stated that she knows nothing about this man. She stated that he was approximately 30-35 years of age.

Lenar stated that when her brother was incarcerated at the Dedham House of

Correction, he telephoned her on one occasion but that he never corresponded with her via mail. She stated that her girlfriend's husband, Phil Johnston, is a guard at the Dedham HOC and that he (Johnston) was informed by Thomas Shay, (Lenar's brother) that he had been mistreated while in lock-up at the facility.

Lenar stated that she had a minimal knowledge of a law suit that her father, (Thomas L. Shay) had filed against a automotive garage. She stated that she had heard from somebody that the lawsuit was not looking to promising after her brother Thomas's deposition on behalf of the suit. She stated that she does not know where or from whom she heard this news.
