REPORT OF INTERVIEW

With Ed Carrion, on February 25, 1992, at 1800 hours, at Rebecca's Cafe, 860 Boylston St., Boston, Massachusetts, by Special Agent Dennis P. Leahy, Bureau of Alcohol, Tobacco and Firearms, Boston Field Division. Mr. Carrion states as follows:

Mr. Carrion said that he is employed at Harvard Community Health Center as a LAN coordinator; work phone #421-2735. Mr. Carrion said that his date of birth is 7-19-54, his residence is on Beacon Street, Boston and his home phone number is 266-1142. Mr. Carrion said that he was a former full time reserve police officer, in Arizona and left on a disability and has since received a settlement. Mr. Carrion said that he is openly gay.

Mr. Carrion said that he first met Thomas Shay (Jr) in the summer of 1988, and that he met Shay (Jr) on the "block". The "block" as described by Mr. Carrion is an area near the Greyhound bus station in Boston where gays meet each other for sexual relationships. Mr. Carrion said that Shay (Jr) was full of anger at his dad and was a real confused kid. Mr. Carrion said that Shay (Jr) told him that his dad worked at an autobody shop and that his mother was a doctor. Mr. Carrion said that he "tricked" with Shay (Jr) at his apartment on Beacon Street. Mr. Carrion said that "tricked" meant had sex with.

Mr. Carrion said that Shay (Jr) took off to New York City at the end of the summer of 1989 and returned about July 1990, when he met Shay (Jr) at

the "block". Mr. Carrion said that he saw Shay (Jr) a lot and that he would buy him dinner and let Shay (Jr) shower at his apartment and then "trick" with him. Mr. Carrion said that he never paid Shay (Jr) for sex. Mr. Carrion also said that Shay (Jr) carried a security badge and would at times say that he was a cop. Mr. Carrion said that Shay (Jr) told him that he had been in New York City working for a hospital ambulance service.

Mr. Carrion said that he gave Shay (Jr) rides to Shay's parents house several times, and that he thought that the house was located somewhere near the end of Blue Hill Ave., in Boston. Mr. Carrion also said that he gave Shay (Jr) rides to Milton; a single family, older house but well kept three or four times in 1989 and two or three times at later dates. Mr. Carrion said that Shay's (Jr) friend/lover lived there. Mr. Carrion could not remember the address. Mr. Carrion said that Shay (Jr) would call him from the "block" for rides. Mr. Carrion thought that Shay's (Jr) friend/lover name was Dave, Bill or maybe Al.

Mr. Carrion said that Shay (Jr) again left for a period of time and showed up in June of 1991, more crazy than ever. Mr. Carrion said that Shay (Jr) said that he was going back and forth to New York a lot from August 1991 through September 1991. Mr. Carrion said that Shay (Jr) was banned from his apartment by his roommate after Shay (Jr) stole a hairbrush. Mr. Carrion said that in late August or early September 1991, Shay (Jr) called the Boston Police and said that Carrion had been drinking and doing drugs for several days and that Carrion was not answering the telephone. According to Carrion the police responded with two marked police cars as well as an ambulance. Mr. Carrion said that he thought it was a Friday night about 2130 hours that this happened.

Mr. Carrion said that he last saw Shay (Jr) about the middle of October 1991, and even though his roommate had banned Shay (Jr) from the apartment he (Carrion) would let Shay (Jr) in because he was a good "trick". Mr. Carrion said that about this time frame Shay (Jr) told him that his dad no longer worked due to an injury and that he tried to live with his dad but that Shay's dad had kicked him out. Mr. Carrion also said that Shay (Jr) talked about coming into money and that Al or Bill would give him \$20,000. dollars.

Mr. Carrion said that Shay (Jr) had an incredible amount of anger and that there was no caring or loving between Shay (Jr) and his father. Mr. Carrion said that he could see Shay (Jr) getting people to build a bomb or building one. Mr. Carrion said that Boston Police Officer Dave Harrington and Officer Kennedy of the Vice squad knew Shay (Jr) well.

Mr. Carrion when shown a photo spread said "I got a gut feeling" and selected the photo of Alfred Trenkler as the friend/lover of Shay (Jr) who lived in Milton. Mr. Carrion agreed to try to locate the house in Milton
