9. DETAILS:

This report pertains to ATF's investigation into the October 28, 1991 bombing which occurred in Roslindale, Massachusetts taking the life of Boston Police Department Bomb Technician Jeremiah Hurley and critically wounding Bomb Technician Francis Foley.

On March 20, 1992 the undersigned interviewed Richard Ahigian and Jim Ahigian, employees of "U Do It Electronics", 40 Franklin Street, Needham, Massachusetts, Tel. No. 617 449-1005.

Both individuals were shown a photograph array consisting of six photographs. Both individuals identified photograph #4, a photograph of Thomas A. Shay, as an individual they recognize. Neither individual could specify where they had seen Shay but stated that they spend the majority of their time within the store and that the likelihood is that they observed Shay inside the store.

Richard Ahigian stated that the individual in photograph #4 (Shay), was tall and thin, approximately 6'2" 190lbs. He stated that he believes he may of had trouble with Shay but that he could not be positive.

Jim Ahigian stated that the individual in photograph #4 (Shay), was approximately 6'0" and thin.

Both individuals recognized photographs of Richard Brown and Alfred Trenkler.

On this same date records were examined for receipts in the name of ARCOMM, Trenkler or Shay. This check proved negative.

On March 31, 1992 the undersigned interviewed " U DO IT Electronics" employee, John Ahigian. Ahigian recognized a photograph of Alfred Trenkler as an individual who shops in " U DO IT ELECTRONICS ". He was unable to identify Thomas Shay.

Jim and Richard Ahigian were re-interviewed and could offer no additional information on Thomas Shay nor Alfred Trenkler

Additionally, on this date a number of employees were shown the photograph array which included a photograph of Thomas A. Shay. There were no positive identifications.

This investigation is continuing.
