9. DETAILS:

This report pertains to ATF's joint investigation with the Boston Police Department into the October 28, 1991 bombing which occurred in Roslindale, Massachusetts taking the life of B.P.D Bomb Technician Jeremiah Hurley and critically wounded B.P.D Bomb Technician Francis Foley.

On April 3, 1992 the undersigned interviewed ~~Shawn Rivers~~, DOB: 3/11/69, S.S #0 and Jacqueline Dunlap, DOB: 5/10/70, S.S #5. Rivers and Dunlap are boyfriend and girlfriend and have moved to Washington State. Currently, there is no available address but they can be contacted through Mrs. Deloris Motz at telephone number ██████████. Rivers is the half-brother of Mr. Scott Critcher, ██████████.

Through separate interviews Rivers and Dunlap both identified Thomas A. Shay from a photograph array.

Rivers and Dunlap stated that they lived at 222 Centre Street in an apartment with Rivers brother Scott. They stated that on ~~October 26~~, 1991 Rivers and his brother Scott hosted a Halloween party at their residence. They stated that they arrived at approximately 6:00 - 7:00 PM. They stated that they remained at the party all night. ~~They stated that they saw Shay at the party and that Shay departed the party sometime after midnight.~~

Rivers and Dunlap stated that the next time they saw Shay was a while after the Halloween party. They stated that they returned home late one evening to find sleeping in their living room, Thomas Shay, Shay's mother and the mother's boyfriend. They stated that they learned the identities
