Mr. Bozyczko stated that he did two excavation jobs for Al Trenkler. stated that a couple of years ago, either in 85 or 86, Trenkler hired him to dig three holes for the footings of a radio tower in Cumberland, RI. He stated that at that time, he was self-employed. He stated that a friend of his by the name of Rick Zach had introduced Trenkler to him. He stated Rick Zach owned a company called Zach Communications. Mr. Bozyczko stated that he also did a one day dig for Trenkler on University Ave. in Dedham, MA. around the same time he did the dig in Cumberland. He stated that he believed that job was for a cable company. Mr. Bozyczko stated that he had to go in person to Cumberland, RI. to demand payment from Trenkler for the two jobs which he said was about \$1500. He stated that he didn't do any other work for Trenkler from thereafter. Mr. Bozyczko stated that he didn't know Trenkler socially and didn't know anything about either Trenkler's lifestyle or drug habits.

When asked about explosives, Peter Bozyczko stated that he has handled explosives because of the nature of his employment (excavation). He stated that explosives weren't used at either job site where he worked for Trenkler. He further stated that Trenkler neither inquired about explosives nor talk to him about them.

Mr. Bozyczko stated that he also had worked for Excavating Engineers, 224 South St., Hopkinton, MA. He stated that he worked for a Joe DiCarlo and that the company used explosives. He stated Jay Bioti & Sons, which is a sewerage utility contractor, didn't use any explosives.

Mr. Bozyczko stated that he is currently living in Framingham with his girlfriend Ellen Gray.
