9. DETAILS:

This report pertains to ATF's joint investigation with the Boston Police Department into the October 28, 1991 bombing which occurred in Roslindale, Massachusetts taking the life of one Boston Police Department Bomb Technician and critically wounding another.

On June 11, 1992 Thomas A. Shay, at his request, was transported from the Suffolk County Jail, 200 Nashua Street, Boston, Massachusetts to the United States Attorney's Office to meet with A.U.S.A. Paul Kelly and ATF Agents Thomas D'Ambrosio and Jeff Kerr. This meeting was conducted subsequent to A.U.S.A. Kelly's being informed telephonically by Attorney William McPhee, previously Shay's attorney, that he (McPhee) had been dismissed by Shay and that he would no longer represent Shay in any legal matters.

During this meeting, Shay continued to ask as well as answer questions. He prepared list's of times he spent with Alfred Trenkler, thoughts he had relative to Trenkler, sexual experiences he had with Trenkler, people that both he and Trenkler knew as well as a number of other Trenkler related areas. He refused to provide this list to anyone present in the room and read aloud from the list for approximately one hour.

Shay stated that an individual named William MacFee had contacted him by letter and later by telephone to reassure Shay that he (MacFee) cared about Shay and that he would consider providing Shay with bail money. Shay stated that he did not know this individual and requested that he (MacFee) not be contacted by investigators for fear of MacFee being scared away.

Shay again requested that he be hypnotised in an effort to gather any relevant information that he (Shay) may subconsciously hold. Shay was informed that his request was under consideration.

Shay stated that he had received a note from Trenkler while incarcerated at the Suffolk County Jail. He stated that he received the note through a Jail Security Officer. He stated that the note said that he and Trenkler would get together and talk once he (Shay) was out of jail.

This interview terminated at approximately 3:00 PM. At this time Shay was escorted back to the Marshal's Office to await transfer back to the Suffolk County Jail.

This investigation is continuing.
