MS SHAM RELATES A CONVERSATION WITH HER MOTHER MRS NANCY SHAM.

SHE (DAUGHTER) SAID THAT HER MOTHER SAID THAT HER SON TOMMY (JR) HAD SAID :

- ① I TOLD JR I WAS SEXUALLY ABUSED AS A CHILD
- ② TOM (JR) TOLD ME HE WAS SEXUALLY ABUSED
- ③ I TOLD (JR) I HAD A SURPRISE FOR HIM (JR)
- ④ AFTER BOMBING I ASKED HOW HE (JR) LIKED THE SURPRISE

- ① THIS CONVERSATION WITH SHAM (JR) NEVER OCCURRED
- ② THIS CONVERSATION WITH SHAM (JR) NEVER OCCURRED
- ③ THE LAST TIME I SAW TOM SHAM WAS WITH JOHN CATES WHEN I WAS PICKING JOHN CATES UP FROM THE FLEET BANK AT COPILEY (BOYSTON STREET) WHEN TOM SHAM WANTED A RIDE DOWN THE STREET. OTHER THAN HELLO AND HOW ARE YOU DOING THERE WAS NO CONVERSATION ABOUT BOMBS, HATRED OR ANYTHING VIOLENT.
- ④ AFTER THE BOMBING, IN DECEMBER OF 91 OR JANUARY OF 92 MY VOICE MAIL SERVICE WENT OFF AND IT WAS A FRIEND OF (JR'S) CALLING TELLING ME THAT (JR) MUST SPEAK WITH ME. I NEVER CALLED THE NUMBER. JOHN CATES WAS AT THE APARTMENT (133 ATLANTIC) WHEN I RECEIVED THE MESSAGE. JOHN CATES AND I BOTH LISTENED TO THE MESSAGE SEVERAL TIMES. I MAY HAVE RECORDED IT - FIND MICRO CASSETTS AT WHITEBURN AVE
