<p>On October 7, 1992, the undersigned, accompanied by ATF Special Agent John Paolillo and Deputy United States Marshal Roger Bryant, interviewed one Nancy Shay, DOB:10/18/44, 200 Falls Boulevard, Quincy, Massachusetts. The interview was conducted at 151 Sea Street, Quincy, Massachusetts, # 600, the apartment of Amy Lenar, one of Mrs. Shay's daughters. Also present was Thomas A. Shay, a subject of this investigation.</p> <p>Mrs. Shay stated that one early morning, prior to October 28, 1991, an exact date she could not remember, she returned home to her apartment at approximately 2:00 AM. She stated that when she entered the apartment she observed an unknown male sleeping on the couch in her living room and her son Thomas A. Shay sleeping on the floor in the same room.</p> <p>Mrs. Shay stated that she was angry at her son Thomas for bringing home a boyfriend to her house for an overnight stay. She stated that she awoke her son and asked him who the individual on the couch was. She stated that her son told her, that the man was a friend of his and that the man was very nice. Mrs. Shay stated that she became enraged and ordered her son to "Get that fucking guy out of my apartment now." Mrs. Shay stated that she then went upstairs and was still angry so she returned half way down the stairs to reinforce her order to her son to get the man out of her apartment.</p> <p>Mrs. Shay stated that she observed her son Thomas and a man she described as short and balding. She stated that the man turned to her son and said that they should leave because his (Thomas') mother was very angry.</p> <p>Mrs. Shay stated that they left the house and that her son didn't return</p>

Mrs. Shay stated that she knows the man in her apartment on the aforementioned night was Alfred Trenkler. She stated that she knows this for two reasons. One reason is that she clearly remembered the man's description and that when she observed Trenkler's photograph in the newspaper she immediately knew he (Trenkler) was the man in her apartment with her son. She stated that the second reason, was her son Thomas' confirmation of the same on a day sometime after the bombing incident on October 28, 1991.
