He is also employed, full time, at the San Michelle Restaurant located at 162 Alcazar Street, Miami, Florida, 305-444-1666. Working at the restaurant his hours are adjustable to his schedule.

Mr. Hernandez said that he met John Cates while he was employed by the Bank of New England in Boston, Massachusetts. He worked there from 1988 to 1989. Since that time he has maintained a relationship with Cates; who informed him of the Roslindale Bombing. They last spoke, as recently as, last month (November, 1992) and discussed developments in the Roslindale Bombing case.

Mr. Hernandez said that he met Alfred Trenkler through his relationship with John Cates however; he could not identify Trenkler by name. He described Trenkler as being short and balding. He said he meet Trenkler only a couple of times; the last time being fourteen or fifteen months

In response to the twenty telephone calls to his house from 617-471-8754 (Trenkler/Cates telephone) to 508-887-9578 (Hernandez's telephone) between 4/24/91 thru 11/11/91 Mr. Hernandez said he and John Cates were friends and he Hernandez could not get into Boston frequently.

When asked if knew the other person alleged to be involved the Roslindale Bombing case Mr. Hernandez could not recall the name but described him as a weird skinny kid with brown hair. Mr. Hernandez further stated that he meet Thomas Shay, Jr. through his relationship with John Cates. He said he met Shay, Jr. on a couple of occasions as the last time was in the fall of last year, 1991. When he had conversation with Shay, Jr. he (Shay, Jr.) claimed to a pilot and on another occasion a firemen.

Mr. Hernandez volunteered his theory on the Roslindale Bombing case. His theory being he believes Thomas Shay, Jr., is involved because he (Shay, Jr.) is nuts.
