REPORT OF INTERVIEW

With Mike Coady, on April 5, 1993, at about 1630 hours, at [REDACTED] by Group Supervisor Victor D. Palaza, and Special Agent Dennis P. Leahy, Bureau of Alcohol, Tobacco and Firearms. Mr. Coady states as follows:

Mr. Coady said that he was about 15 years old (1985) when he met Al Trenkler and that Trenkler supplied him with drugs and after several months sexually molested him. Mr. Coady said that he was not gay and that being sexually molested "fucked my life up." Mr. Coady said that he dropped out of high school and basically was a street person for a time. Mr. Coady said that he knew Trenkler from about 1985 through 1987. Mr. Coady said that Trenkler was a drug dealer who also used drugs, and that Trenkler was dealing and using about 1 ounce of cocaine a week.

Mr. Coady said that Trenkler was extremely manipulative and had a sexual obsession with younger males. Mr. Coady said that Trenkler stole money for drugs from his grandmother who was very wealthy and at one time married to P.T. Barnum. Mr. Coady said that Trenkler was an "electronics whiz" and that he went with Trenkler to a telephone pole, near Wilmington Ford, where Trenkler did some electronics work. Mr. Coady expressed strong distaste for Trenkler and feels strongly that by Trenkler sexually molesting him it has caused great mental anguish to him. Mr. Coady also said that Trenkler liked multiple male sexual partners at the same time and that Trenkler used to frequent the Blue Hills, lookin for male sexual partners.
