Now comes the defendant, by his counsel, and requests that the  
above case be continued for two weeks from October 25, 1993, until  
November 9, 1993.


In support of this motion defendant states:

1. On October 4, 1993, defendant's counsel will begin the  
trial of Commonwealth v. Haskard (see enclosed), a first degree  
murder case in which a husband and wife are charge with killing  
their one month old daughter. The indictment in said case was  
returned in September, 1992, and the trial is expected to take 2-3  
weeks. Defendant's counsel has been informed it is unlikely  
Justice Sarris will preside at the Haskard trial, and will not know  
until mid-September who the trial Justice will be.

The trial of this case, also involving a possible life  
sentence, is expected to take 3-5 weeks, and defendant's counsel  
would appreciate the chance to have 7-14 days between the  
conclusion of the Haskard case, and the beginning of this case to  
adquately make last minute preparations for this case.

Wherefore, defendant, by his counsel, respectfully requests this  
case be continued from October 25, 1993, to November 9, 1993.


