MOTION TO QUASH

Thomas A. Shay hereby moves to quash the subpoena served upon his counsel on October 18, 1993, commanding him to appear and testify in United States v. Alfred W. Trenkler. As reasons therefor, Thomas A. Shay states as follows:

1. On October 12, 1993, Thomas A. Shay filed his notice of appeal of his conviction and sentence.

2. Thomas A. Shay therefore continues to possess his right against self-incrimination, guaranteed by the Fifth Amendment to the Constitution of the United States.

3. Thomas A. Shay will exercise his Fifth Amendment right if required to appear at Trenkler's trial.

For the reasons stated above, Thomas A. Shay moves that this Court quash the subpoena commanding him to appear and testify at Trenkler's trial.
