I Received your letter Today & am looking Forward To our future conversation via the Telephone. There are Several ISSUES which I was Hoping The wallaces would Help me out on IN which I needed a Few Hundred Dollars To accomplish IN an ATtemp TO Re-open my side OF The case and SHed new light ON AL'S. I was virtually coerced By my former ATTORNEYS TO Plead Guilty. I, Mr. Goldings, am Truly INNOCENT. your client IS also INNOCENT. There IS actually NO Sure way TO Prove our INNOCENTS except By Tearing Down The House OF Frabile cards, one By one. I want TO File Two motions IN the court. The first IS InEFFECTive counsel TO The court & By law suite. The Filing fees will cost about \$600. I Had 3 ATTORNEYS and In Filing against Two as the Third, a Friend & non-Partner OF The Firm was also coerced INTO coercing me TO Plead Guilty. She was Basicly Forced, TO force me TO Play Ball & Save the Firm \$! AT a meeting with These ATTORNEYS The night Before I Plead, my mother nancy SHAY Hm617-471-3556, wk. 617-261-6017, my sister Paula SHAY Hm603-437-3566, and my other sister Amy Levar Hm. 617-696-2749, They were with my ATTORNEYS IN a conference Room Speaking TO me on a speaker phone. While I was at Plymouth county Jail Oct-98. Throughout The conversation was my known INNOCENTS. my lawyers said IT was Better This way. my sister nancy who lives with

my mother, did not want me to plead guilty. She was also present at the conference call. an hour before I plead guilty I met an old attorney of the firm who was then & is now still a Federal Judge and I told her I was innocent, she said she knew and she gave me a hug. There is no way to prove our INNOCENTS but there IS, ARE ways to getting accepted Appeals. Through F.O.I.A. we could probably prove that Boston Homicide lied when they said they made no notes. all cops make notes. The Prosecution had them and as time passes cops will forget what they said years earlier. If we can prove they perjured themselves ITS a small score. I made a C-plea and it claims I cant produce my INNOCENTS. another attorney I had Jefferson Boone 617-782-8210 will tell you how he was treated by my other attorneys to give up his space on my case.

ask him if he can tell you about a guy named kris from the W. Roxbury "Parkway Transcript" I guess this reporter kris knew I was innocent also and was doing some good digging on all of our behalfs. there are 2 sets of suspects for me. (1) my father & his scheming attorney (no offense) or the guys my father was suing. I can actually prove my Dads lawsuit which an insurance company paid him was all baloney! anyway, thats it for now. I will call when possible. let me know if the wallaces can arrange the \$700., \$600. for the fees & \$100 for copies & postage!
