IN COLANNE'S 10-30-91 INTERVIEW - ELEANOR MCKERNAN WAS AWAY FROM THE HOUSE AND UPON HER ARRIVAL SR HAD PARKED HIS CAR IN A WAY THAT MADE IT DIFFICULT TO ACCESS HER DRIVEWAY.
