Thomas Shay, jr. is arrested in Seattle for possession of stolen property. ATF report of invest #11

**June 1991**

Shay reportedly lives in Seattle Washington ATF Report of Invest #76 int. w/Robert Freeman - Freeman will say that he let Shay live with him for 3-4 days in a car and that Shay was "having problems with his mother, and had very little if any contact with his father." Subsequent conversation with Shay's mother reveals (according to Freeman) that TS, jr. is in Bridgewater for evaluation. (Not possible - TS, Jr. admission to Bridgewater was prior to June of 1991)

**October 29, 1991 - B (Gov. Disc. File - Thomas Shay, Jr.)**

TO: Boston police detectives Thomas and O'Malley

Reason for Contact/Circumstances indicating in custody: "was beeped to respond back to the Homicide Office to speak with Thomas A. Shay"; at home unit office, 2 armed detectives present, was brought there by another cop. Never told he was free to leave.

Time/Place: Homicide Office after 2:30 A.M.

Statements to Suppress:

"I know you guys have the phone taped that's why she wouldn't let me talk to my father."

"Have you ever been to a boys school, do you know what their like, maybe things would be different if I hadn't gone to them."

-When he was younger he would go to South Carolina and purchase 1/4 sticks and he and his friends would use them to blow up a submarine he owned.

-Was present when barrel blew up at service center, injuring his father. He "knew what was in the barrel, that's why it blew up so high."

-Motive: Father's atty told him his father would get a lot of money (over \$250,000) if he won his lawsuit (re the injury from the barrel). Then smiled. (Father's atty denies this; ATF interview of one of the sisters says Tom smiles when he's lying, looks serious when tells the truth).

Elicitation: yes: reason for being there was to talk to Tom, pressed about why he took so long to visit his father, asked questions about childhood, family background and relationships, and whether he ever played with fireworks

Miranda: NONE

Waiver of Right to Remain Silent/Right to an Attorney's Presence: NONE

Request for Atty: NONE reported

Request to Remain Silent/Cut off questioning: NONE reported

Police Awareness of State of Mind: appeared agitated and stated that he had tried to contact the home of his father by phone since seeing the 10 o'clock news on channel 56 . . . Mary [stepmother] answered and would not allow him to talk to his father . . . "I know you guys have the phone taped that's why she wouldn't let me talk to my father. . . Have you ever been to a boys school, do you know what their like, maybe things would be different if I hadn't gone to them." Shay appeared very unhappy when talking about boys schools. Shay was sent to these schools after the divorce of his mother and father.

**October 31, 1991 - C**

Shay, jr. Statement at Greyhound Bus Station Press Conference (Gov. Disc. file - Thomas Shay, Jr.)

Police videotape: Shay refers to: -cops tricked me; pieces of wires in someone's house; referring to someone named Pace, suggesting that the bomb was intended for him

October 31, 1991 - D (1st half)

To: Boston Police Detectives O'Malley, Thomas and Fogarty  
and ATF Agent Bowen

Reason for Contact/Circumstances indicating in custody:  
after press conference at Trailways Bus Station called by  
Tom, detectives "asked" Tom to come with them to the  
Homicide Unit and he "accompanied" them. Later in the  
interview (pre-arrest part), they supposedly get him to say  
he came with them "freely and was not forced." But after  
that, Tom's perspective was that he was in custody because  
he asked twice if he could leave. Was never told upon  
arrival or until then that he was free to leave. At Home  
Unit office, 5 armed police, was brought there in a cruiser.  
In Tom's 3/25/92 press release to SF news editors, says  
during this session, where he was "grilled for over fifty  
minutes," the cops accused him of having something to do  
with the bombing.

Time/Place: 10:00 P.M., Homicide Unit conference room

Statement to Suppress:

- wanted to take a polygraph test
- again stated had no access to his father's house
- re barrel blowing up at garage: very explosive paint  
thinner and a class C quarter stick, which is made in SC &  
he's been to SC & you can light off fireworks in a park just  
b/f you leave the state
- used to throw M80s at model submarines; M80s are waterproof
- denied he said to Bridgeforth that he wished he could turn  
the clock back
- Asked about comments to press that the explosive was "C  
something" and Tom said it was a guess. **(any such comments)**

-Request to Remain Silent/Cut off questioning: At 10:40  
asked if he could leave after being told father coming over.  
Was told he could leave

-but cops cont'd. to ask questions re where he learned about  
explosives and remotes to which Tom answered he learned  
about explosives and remotes from TV; probably asked why he  
wanted to leave because Tom said he didn't want to see his  
father b/c he'd hit him as he had in the past (more motive).

-Asked again if he could leave again and he did, rearrested  
at 10:48.

Elicitation: often says Tom "stated" this & that, but must have been asking questions; sometimes says "when asked" about this or that

Miranda: None

Waiver of Right to Remain Silent/to an Atty: NONE

Request for Atty: None reported

Police Awareness of State of Mind: This followed the press conference (see tape) at which cops were present when reporter mentioned psych history. Noted in the report is that Tom said at the conference that the bomb was meant for him b/c he owed Pace 50,000 and he'd be in Boston Common next day if Pace wanted to talk to him. Stated he had all the videos from TV stations and all newspaper clippings. Stated was going to have a press conference with mother next week. Tom asked how media knew so much about his past personal life and cops said it came from his father's lawsuit. Was at the Gable School at Waltham Met. State Hospital and graduated from Baird Center.

Trickery:

-Cops asked about comments to newspaper about remote control & Tom denied it. Asked about comments to press that the explosive was "C something" and Tom said it was a guess. Dianne Gamere says check of newspapers shows he never made such comments.

-Cops told him his father was coming over to see him, upon which he asked if he could leave. Tom told Emmet his father was not really coming, that they told him that to keep him there longer (or maybe to get his reaction?)

Request to Remain Silent/Cut off questioning?: at 10:50 he called Pitts at Ch. 5, told whoever answered to call mother and tell her he'd been arrested, reportedly did not ask to make other calls. Tom told Emmet he did not mention an attorney to the cops or during the phone call at this time.  
-when cops looked in black bag and saw newspaper clippings with black tape on them, he "became very concerned"  
-drew diagram of remote control device & explained how it worked after being shown a remote control device by police  
-the police are going to frame me because I'm the one with fires in my past when I was little  
-confessed to the bomb threat at the Back Bay MBTA station previous year  
-Request for Atty: very definite  
-called Bonano and stated the police thought he'd set the bomb at his father's home (possibly no elicitation here)

Elicitation: YES: asked questions and showed him a remote control device.

Police Awareness of State of Mind: all knowledge gained earlier plus stated he was raped at age 10

**Nov 5 or so**

met at the Dedham House, shay said that he was the kid iv been reading about, his uncle and him used to make bombs, that his uncle was a bomb expert in the service, not have anything to do with it, not even in the state constanc cry baby ember 1, 1991

**Evans:**

interviewed by BPD detectives Peter O'MNalley, Miller Thomas and William Fogerty (in D'Ambrosio affidavit): Evans told the detectives that he had been placed in an accompanying cell to Shay Jr. earlier that date (November 1, 1991)

that he asked shay jr how he made the bomb, and shay jr. replied that he was not smart enough to make bomb, but that he bought it off a guy who made it and stuck it over there." Evans asked if shay jr father would bail him out, shay jr sayss "What eare you crazy? After what I tried to do to him?"

To Dr. Luber during competency evaluation at the Boston Municipal Court prior to admission to Bridgewater-not reviewed yet-attached. (Dr. Luber's report outlines the events leading up to admission to Bridgewater.)

March 24, 1992 - I  
(1) Upon Arrest.

Tom Shay, Jr. arrested in SF. Statement: he tells them he has been Reno, using a false name, James Keough the name of his sister's boyfriend, and carrying his military id.

ATF report of invest. (#71) Statements made by Shay in car with officers prior to being made aware that he is with cops. "Just returned from Reno"; "put \$30,000 into slots"

(2) Upon arrival at station.

[Really no statement to worry about here-this is important because it creates a Mosley/Barone challenge and causes Edwards to kick back in in case we are subject to a break in custody rule]

To: ATF Agent Kerr, Boston Police Detective Armstrong (no mention of ATF Leahy or BPD Craven being present at this time)

Reason for Contact: arrested on fed flight to avoid pros warrant.

Time/Place: S.F.P.D. Central Station upon arrival after arrest (between 3:20 and 4:00-this clearly precedes the Leahy/Craven interview b/c it happened right when Kerr brought him in after arrest)

Statement to Suppress:

-Miranda by Armstrong

-Waiver of Rights: Tom supposedly requests his rights not be read, but never expressly waives them and almost immediately invokes them.

-when cops explain substance of warrant, Tom replies that Kerr and Armstrong are there to blame him for bombing; scapegoat needed in Boston and he was it.

-requests attorney by name (McPhee), states does not wish to speak with anyone

Elicitation: does not mention questioning until just before request for atty/to remain silent

Awareness of State of Mind: ATF file makes clear they knew all about Tom's craziness by now

(3) After arrival at station.

[Challenge: Mosley, Edwards, Jackson, no Miranda, involuntary]

To: ATF Agent Leahy and Boston Police Detective Craven

Reason for Contact/Coercive circumstances: arrest on fed flight to avoid pros; In Tom's 3/25/92 press release to SF news editors, says he was assaulted by one officer during questioning in SF. Tom told Emmet Craven or Leahy, who resemble each other, slapped him.

Time/Place: SFPD, Central Station, 4:00 A.M.

Statements to be Suppressed: (ATF Report #64)

-NOTE THAT EARLIER REQUEST FOR COUNSEL & NOT TO TALK STILL IN EFFECT & NO MIRANDA, so Tom's alleged statement at the beginning, "ask me questions" cannot be a valid waiver under Edwards or (probably) Mosley/Barone.

-black tape had nothing to do with bombing

-met Trenkler, slept with him, went to party with him, went to his house once; went to Trenkler's work site once & watched him work

-can get remote control stuff at Child World

-will not help myself to 100 years in prison

-cuts off questioning again: will not talk about bombing incident

-you'd never have caught me except for the postcards

-at a Halloween party Fri, Sat, & Sun at Scott's before bombing (all wits say he was there for an evening, left sometime after midnight)

-(Tom falls asleep)

Supplemental Report (ATF Report #65) (still says time of "0400 hours", but this either took place after Tom woke up or was prepared after they realized he'd already invoked his rights to the other two officers or they just remembered this part later; Tom told Emmet this took place at same time, all of a piece). Says "after a period of silence in response to no question," Shay stated his lawyer said he wouldn't do much time b/c of history in homes and institutions, and asked about notorious insanity defense cases. When the cops told him they all got convicted, Tom said, "I guess I am going to be getting a lot of sex in the can."

Elicitation: yes-asked many questions, press release says feds told him Trenkler was a suspect which elicited whatever

he said about Trenkler; the supplemental report tries to make that part look like Tom initiated it (Woods v. Clusen is a good case here).

Police Awareness of State of Mind: knew all plus late and very tired (fell asleep at end)

March 26, 1992

ATF report of invest (#67) Statement of Fred Burke to San Francisco investigators - Shay told Burke that "some sicko" was involved in bombing of his father; father involved in gambling.

[Challenge: Edwards, Jackson, Mosley/Barone, involuntary]

Reason for Contact: while transporting Tom from San Francisco County Jail to District 4, Boston; armed cops, handcuffed off and on, under arrest.

Time/Place: beginning 6:15 AM (SF time); cruiser, airplane, "wagon"

Statement to be Suppressed:

-Miranda at 6:30 AM on the way from jail to airport; Tom answers he's fully aware of rights

-Waiver: no express waiver

-Edwards right to counsel and Mosley to remain silent still in effect from 3/24.

- "all of a sudden with no reference to anything" Tom says he didn't build no bomb, tells what may be a story in conflict with earlier one re where he was day of bombing, how he found out.

- on trip w friend to Seattle, friend learned to build bombs; "you could buy stuff there"

Elicitation: doesn't ever say they asked him anything, but they clearly were- i.e., says he "would not state this friends name." Later: he "clammed up until landing time."

Police Awareness of State of Mind: very interested in what media saying about him, what police officers think of him; called friend fr. SF airport b/c wanted friend to alert Boston media he's on his way; on plane kept to himself & laughed every so often softly; when plane took off looked very scared and as though about to cry; worried about time; talked about plane blowing up; about how hard his life was; upon arrival, "started whimpering again," wanted to know what was going on, afraid of the feds and upset at sight of ATF agents; in wagon to District 4 was very excited & happy that media met him, said wasn't one of his better interviews.

Comments: Why was he held so long in San Francisco (in press release to SF news, Tom says b/c he resisted going back to Boston, so Weld had to submit an extradition warrant to Ca Gov Wilson) What happened there? Says was visited by CIA (ATF?) who asked for diagram of bomb and where got explosives, slapped him-Tom told Emmet Craven or Leahy slapped him, apparently on 3/24/92.
