AT LAST, HERE IS THE SHAY JR WRITE UP! I'M SURE YOU WILL HAVE MANY QUESTIONS.

WHAT I SEEM TO SEE ABOUT SHAY JR WAS THAT UNTIL AROUND JUNE OF 1991, WHEN SHAY SR BROUGHT HIS SON BACK TO BOSTON FOR THE LAWSUIT DEPOSITIONS, SHAY JR WAS NOT IN THE BOSTON AREA AS FAR BACK AS MID 1989. SHAY SR WENT TO DARTMOUTH MASS TO GET SHAY JR WHERE JR WAS LIVING WITH RUSS BONANO.

ALSO THERE IS AN INTERVIEW WITH CHARLES HELLYER, A DISPATCHER FOR GREYHOUND BUS IN BOSTON, WHERE HELLYER TELLS THE ATF THAT HE SAW SHAY JR 2 OR THREE YEARS PRIOR TO NOVEMBER ~~10~~ OF 1991 WHICH GOES BACK TO NOVEMBER OF 1988 OR 1989. HELLYER NEVER SAW ME OR HEARD OF ME, BONANO NEVER SAW ME OR HEARD OF ME.

RANDY STOLLER LIVES IN THE ATTLEBORO MASS AREA WHERE SHAY JR SPENT SOME TIME. UNTIL JUNE OF 1991 STOLLER NEVER MET ME OR HEARD OF ME.

AGAIN, IT SEEMS AS IF THE ONLY REASON SHAY JR WAS IN THE BOSTON AREA IN THE SUMMER OF 1991 WAS BECAUSE HIS FATHER BROUGHT JR BACK FOR DEPOSITIONS IN HIS LAWSUIT.

THERE WAS ALSO A MENTION THAT SHAY JR WAS INVOLVED WITH POLICE IN FLORIDA AND WASHINGTON STATE BETWEEN 89 AND 91. THIS IS BASED ON THE ATF REVIEWING POLICE RECORDS IN FLORIDA.

THERE IS NO EVIDENCE IN ~~1989~~ 1989 OR 90 THAT I WAS WITH SHAY JR IN FLORIDA OR WASHINGTON STATE.

NONE OF SHAY JR'S FRIENDS SAID THEY EVER SAW ME AND SHAY JR TOGETHER (CARRION MAYBE, I'M STILL CHECKING) STOLLER IN JUNE. OTHER THAN CARRION AND STOLLER NONE OF SHAY'S OTHER ASSOCIATES EVER HEARD OF ME OR SAW ME WITH OR WITHOUT SHAY JR.

EVEN JUDGE ZOBEL REALIZED I DID NOT KNOW SHAY JR AS WELL AS THE GOVERNMENT SO DESPERATELY TRIED TO PROVE. ZOBEL MADE THE STATEMENT THAT MY RELATIONSHIP WITH SHAY JR ~~WAS~~ WAS "RELATIVELY SLIM" DURING A HEARING - I'LL LOCATE THAT FOR YOU.
