

- (4) Specify the date of the initial request and the date of the letter denying the initial request; and
- (5) Petition the OIP, to grant the request for records and state any arguments in support thereof.

Your appeal will be considered by the OIP and you will be notified by mail.

After we have received your agreement to pay for the expected fees (or you have narrowed your request to reduce fees) and we have processed your request, we will require payment for the accumulated charges before we release documents to you. Without such payment, your request file will be closed without further action.
