RE: Roslindale Bomb Blast

Dear Governor Patrick,

Sir,

My name is Thomas Shay. I am one of two men whom was convicted of conspiring to build a bomb which later killed a Boston Police officer and injured a second officer.

Sir,

At the time of the offense, it is my honest belief that the Boston Police were on the right track in their investigation of my father, Thomas L. Shay. He had Mob ties, gambling debts and actually became paranoid of bombs of all things prior to the explosion before one appeared under his car.

The ATF took over the investigation shutting out the Boston Police and its suspicions and focused on myself and a man I barely knew for eight hours. At the time I was a mentally ill teenager who made up lies for attention from an ever increasing feeding frenzy of the Boston news media.

Later on, the ATF came up with a piece of evidence they claimed linked me to the bomb, a Radio Shack receipt. But since then, we have come to find out that this receipt doesn't even exist. Enclosed you will find the receipt and an Affidavit of the Tandy Corporation General Counsel, say it to be fraudulent, which brings us to the conclusion of why would the A.T.F. use this fraudulent evidence to make their case if they thought we were guilty? Or maybe they needed some positive publicity after Waco and Ruby Ridge?

Gov. Patrick,

As a human being, I am asking you not to just open your heart, but also your mind. You must realize that things are not adding up to Guilt, but to doubt. Not only do Alfred Trenkler and myself deserve exonerations but

Officer Jeremiah Hurley and Officer Francis Foley deserve justice. And your public deserve to feel real safe, and know the truth. Please reopen this investigation.
