On October 30, 1991, the U.S. Army records of SHAY, Thomas Leroy and SHAY, Arthur James, and the U.S. Air Force records of DOERING, John James were reviewed at the Military Personnel Records Center, 9700 Page Blvd., St. Louis, Missouri.
