COLLATERAL REPLY INFORMATION

This 3270.2 is generated to transmit the enclosed information obtained from the Seattle Police Department, Seattle Washington, regarding the subject Thomas Arthur Shay (DOB: 11-03-71), arrested 09-023-90 in Seattle for possession of stolen property. This information is transmitted by request of Lieutenant McNally with Boston PD Homicide and Guy Hummel Special Agent in Charge - Boston District. Thomas Shay is a suspect in the October 29 1991, bombing incident in Boston that resulted in the death of one Police officer and the serious injury of another.

On October 30, 1991, at approximately 2100 hrs, the enclosed SPD incident report, mug shot, print sheets and property log were sent by fax to Lt McNally at Boston PD Homicide (Telephone# (617) 247-4560).

On October 31, 1991, at approximately 1100 hrs, Special Agent Bishop with ATF Seattle II, interviewed SPD Officer L. Ross (ID #5487) (Telephone # (206) 684-4300) regarding the arrest incident involving Shay that occurred on 09-23-90. Officer Ross remembered the incident and reported that initial contact with Thomas Shay had been made at a Gay Bath house. Shay was found in possession of several stolen savings bonds, stolen credit cards and miscellaneous jewelry. Officer Ross recalled that Shay repeatedly claimed he was under 18 years of age and had in his possession a Massachusetts drivers license. Ross also recalled Shay as being "very arrogant, cocky and overconfident" and while confined in jail he boldly announced in a bragging manner that he had slept with over 100 men. Officer Ross could recall no other details involving the arrest but indicated if she remembered anything else she would contact S/A Bishop in
