THE INTERVIEW ON 5 NOVEMBER 1991 TO 6 NOVEMBER 1991 WAS PURE HARASSMENT AND SCARE TACTICS WITH BOTH IDLE AND ACTUAL THREATS OF PHYSICAL HARM TO ME AND OR JOHN CATES PET DOG. THERE WERE 15 AGENTS OUTSIDE THE APARTMENT DOOR AND PROBABLY ANOTHER 15-20 OUTSIDE THE HOUSE "JUST IN CASE I DECIDED TO LEAVE" ALTHOUGH THERE WAS NO ARREST WARRANT. THERE MUST HAVE BEEN 7-10 CROWN VICTORIAS PARKED AROUND THE HOUSE

AS YOU NOTED, THE GOVERNMENT WAS TRYING TO PUT A NASTY SPIN ON THE GAY ISSUE. THE ATF AGENTS MADE THE ASSUMPTION THAT JOHN CATES AND I WERE GAY LOVERS SO PUT IT IN THE REPORT. CATES AND I WERE FRIENDS THAT SHARED AN APARTMENT, HE WAS DYING FROM THE RAVAGES TO HIS LIVER CAUSED BY HEPATITIS B. WE COULD NOT HAVE A PHYSICAL RELATIONSHIP WITHOUT ME BEING INFECTED - A POINT THE GOVERNMENT CONVENIENTLY GLOSSED OVER.

CONTRARY TO THE REPORT, NEITHER I NOR CATES CONSENTED TO A SEARCH WARRANT. THE AGENTS TOOK CATES OUTSIDE TO A CRUISER AND KEPT ME IN THE APARTMENT. MOMENTS LATER AN AGENT CAME INSIDE AND SAID CATES SAID IT WAS OK TO SEARCH AND PROCEEDED TO DO SO. THEY SEARCHED AND FOUND A SMALL AMOUNT OF MARIJUANA DUST IN THE CORNER OF A BAGGIE STUFFED INTO A COUCH. THE AGENT THEN WENT OUT TO THE CAR WHERE CATES WAS, HELD UP THE BAGGIE AND ASKED IF THAT WAS THE REASON CATES DID NOT WANT THE SEARCH. CATES SAID THAT WOULD CERTAINLY BE A GOOD REASON NOT TO SEARCH. THE AGENTS NOTICED A SPEAKER SITTING ON A SHELF IN THE KITCHEN, CATES HAD FOUND IT IN THE TRASH ONE DAY SOMETIME PRIOR TO MY MOVING IN FIGURING HE MIGHT USE IT FOR SOMETHING WITH HIS STEREO SYSTEM.

THE BOOK "DIRTY TRICKS" BELONGED TO THE OWNER OF THE HOUSE MIKE GREEN, HE HAD LEFT IT IN A UTILITY CLOSET IN THE APARTMENT AND TOLD THE ATF AGENTS IT HAD BEEN GIVEN TO HIM AS A GIFT SOME YEARS AGO.

AS USUAL THE ATF AGENTS STRETCHED THE EVENTS OF THAT EVENING/
MORNING. THE AGENTS, LEAHY, DAMBROSIO AND BOSTON POLICE
DETECTIVE PETER O'MALLEY - THE SAME FAMOUS STEWARD MURDER
DETECTIVE - WERE ASKING IF I KNEW THE DIFFERENCE BETWEEN
A TV REMOTE CONTROL AND A TOY REMOTE CONTROL WHICH ANYONE
IN COMMUNICATIONS KNOWS ONE IS INFARED LINE OF SITE ~~AND~~
USED FOR TV AND TOYS USE A RADIO FREQUENCY CONTROL.
THEY ASKED HOW THE 91 DEVICE WAS CONSTRUCTED AND I TOLD
THEM IT HAD BEEN A WHILE AND DREW A ~~RAY~~ RECEIVER AND
THE SIMULATOR AND SIMPLY EXPLAINED THE RECEIVER SENT POWER
TO THE SIMULATOR.

THE AGENTS ASKED IF I HAD ANY IDEA HOW THE 91 BOMB WAS
MADE, I TOLD THEM THAT I HAD NO IDEA SINCE I HAD NOTHING
TO DO WITH IT. THAT WAS ALL THAT WAS SAID ON THE SUBJECT
CONTRARY TO THE JANUARY 17, 1992 REPORT WHICH WAS WRITTEN
SOME TWO AND A HALF MONTHS AFTER THE INTERVIEW.

AN OBSERVATION - THE REPORT SAYS THAT I "DREW A DIAGRAM
OF AN ELECTRICAL CIRCUIT WITH A ^(SIC) ELECTRICAL DETONATOR (BLASTING
CAP) TO EACH STICK OF DYNAMITE; SHOWING TWO STICKS OF
DYNAMITE AND TWO ELECTRICAL DETONATORS IN THE BOMB".
IT IS UNDISPUTED THAT THE 91 BOMB DID NOT CONTAIN ANY STICKS OF
DYNAMITE IN FACT IT WAS LISTED AS 3-5 POUNDS WORTH OF
DYNAMITE WRAPPED IN A MAGAZINE PAGE WRAPPED WITH TWO
TYPES OF TAPE WITH, ACCORDING TO THE FBI, 3 BLASTING CAPS
CONTAINED.

I NEVER SAID I HAD ALL THE TOOLS TO BUILD A BOMB

I DID NOT SAY I STOPPED BY 133 ATLANTIC AVE (CATE'S APARTMENT)
WITH SHAY ON FOUR OCCASSIONS. I SAID THAT ONE TIME, THE
MORNING I ~~WAS~~ MET SHAY, I LET HIM STAY AT CATE'S APARTMENT
FOR A FEW HOURS.

NEVER ONCE DID I SAY ~~NO~~ TO THE ATF THAT I WAS GAY

THE ATF SAID THAT THEY KNEW I KEPT EQUIPMENT AT MY PARENTS'
GARAGE AND NEEDED TO SEARCH IT. I TOLD THEM NOT AT THIS
LATE HOUR, MY PARENTS WERE ASLEEP AND IT WOULD UPSET
THEM. THE AGENTS SAID THEY WOULD TELL MY PARENTS THEY
WORK FOR ME AND WE NEEDED SOME EQUIPMENT FOR WORK.
I FIGURED THEY WERE GOING TO SEARCH NOW OR LATER SO
THEY MIGHT AS WELL GET IT OVER WITH, I HAD NOTHING TO DO
WITH THIS BOMBING AND HAD NOTHING TO HIDE.
