



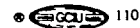

BOSTON POLICE PATROLMEN'S ASSOCIATION AND BUREAU OF ALCOHOL, TOBACCO AND FIREARMS ANNOUNCE \$50,000 REWARD FOR INFORMATION ON THE OCTOBER 28, 1991 ROSLINDALE BOMBING

Boston Police Patrolmen's Association President Donald L. Murray and the Boston Field Office of the Bureau of Alcohol, Tobacco and Firearms (New England) Special Agent in Charge Terence J. Mc Ardle today announced that the two agencies have joined together and are offering rewards totaling \$50,000 for information leading to the arrest, prosecution and conviction of the individual or individuals responsible for the October 28, 1991 Roslindale bombing which resulted in the death of Officer Jeremiah J. Hurley and the maiming of Officer Francis X. Foley.

In making the announcement Officer Murray said, "The 1416 men and women of the Boston Police Patrolmen's Association are determined to bring the individual or individuals responsible for the murder of Jerry Hurley and for the serious injuries inflicted on Frank Foley to the bar of justice as quickly as possible. The crime that they committed was heinous and dedicated personnel have been working around the clock to solve the case.

"However, we realize that the offer of rewards has been instrumental in the past in eliciting information and so the Association is offering \$25,000 for information leading to the arrest and conviction in the Eastbourne Road bombing," Officer Murray said.

"I also want to thank the ATF for their dedicated efforts in this investigation and for joining us in offering a reward," Officer Murray concluded. "I know that all honest, law-abiding citizens are with us in this effort and I count on their support for a speedy resolution."

Special Agent in Charge Mc Ardle added, "The Boston Field Office of the ATF has been working very closely with the Boston Police Department to solve this crime. To help expedite the case, we are offering a reward of \$25,000 for information leading to

the arrest and prosecution of the individual or individuals involved.

"I cannot stress the seriousness of this crime enough," Special Agent in Charge Mc Ardle concluded, "and I pledge the full cooperation of my agency for the duration of the investigation."

To facilitate the receipt of information both the Boston Police Department and the Boston Field Office of the Bureau of Alcohol, Tobacco and Firearms have set up 24 hour hot lines. The Boston Police Homicide Unit number is (617) 247-4470 and the ATF number is (617) 565-7040.
