

9. DETAILS:

On 11/12/91 Special Agents Carney and Jones interviewed Jack Sodillo relative to a alleged bombing incident in 1988. Sodillo stated that he is the owner of Sodillo's Auto Body Shop at the Dedham Services Center, Washington Street, Dedham, Massachusetts. Sodillo stated that he first met Anthony Manna buy doing auto body work on Chevy Impala in 1986. Sodillo stated that he and Manna were on friendly terms at the time and he felt that they had a good working relationship. Sodillo stated that in 1988 his business was located in Hyde Park, and that while at location he experienced several acts of vandalism. Sodillo stated that motor vehicles and the auto body shop itself were burned. Sodillo stated that his motor vehicle outside of his residence was also burned in 1988.

Sodillo stated that while the acts of vandalism were occurring he still maintained his relationship with Manna, because he did not know that Manna was responsible for the Vandalism. Sodillo stated that the incident went unsolved until 1990. Sodillo stated that Manna called and left a message on his answering machine admitting to the acts of arson, because Sodillo was gay. Sodillo stated the matter is still being adjudicated and that if ATF needed more information Brain Flynn of the Boston Police Department and Jay Reed of the Suffolk County District Attorney's Office could be contacted.

Sodillo stated that he does not know Thomas Shea personally, but is familiar with Shea's auto body repair work which customers have stated is insufficient. Sodillo stated that he does not know Thomas Shea Jr., Robert Thompson, or Alfred Trenklar.
