

REPORT OF INTERVIEW

With Rosalyn Rotman, on November 5, 1991, at 4:30 P.M., at 32 Devine Road, Randolph, Ma., by Special Agent John S. Paolillo and Special Agent Henry J. Moniz Jr., Bureau of Alcohol, Tobacco, and Firearms. Mrs. Rotman states as follows:

Mrs. Rotman said that she's lived at 32 Devine Street, Randolph for 35 years with her husband Louis Rotman. They have two children; a daughter, Amy Rotman (Leavit) who is a Registered Nurse and lives at 102 Adeline Road, Newton, and a son Ernest Rotman who is a Physicians Assistant at Brockton Hospital and lives at 6 Sandy Ridge Circle, Sharon.

763-6575- Mrs. Rotman further stated that her and Mr. Rotman own a clothing and tailoring shop in Randolph called Clothes Quarters. One night after closing the shop Mr. and Mrs. Rotman were leaving the shop when they noticed damage had been done to the left quarter pannel of their vehicle. They reported the damage to the police department and filed a claim with their insurance company. Subsequent to the damage to their vehicle Mr. Rotman contacted Mr. Thomas Shay to repair the damage done to the vehicle. Mr. Shay agreed to repair the vehicle and in return Mr. Shay would loan the Rotman's his vehicle (86' Buick) until their's was repaired. Mrs. Rotman indicated that her husband has known Mr. Shay for approximately three years but, she did not recall how the the two knew each other.

Mrs. Rotman said that on 10/14/91 her husband brought their car to Mr. Shay for the repairs that it needed. Mr. Shay in turn loaned the Rotman's his car until theirs was repaired. Approximately two weeks later Mr. Shay brought the Rotman's car back to their clothing store in Randolph. Mrs. Rotman paid Shay for the work he had done and both parties exchanged their vehicles back to one another.

On 10/28/91 Mrs. Rotman heard about the bombing on either the 6:00 or 11:00 news. Mrs. Rotman was concerned thinking that the bomb that exploded was attached to a vehicle that her and her husband had used for two weeks. Mrs. Rotman had her husband call the police to report this because she felt that her and her husband might be in some danger. The police department refered the Rotman's to the fire department and according to Mrs. Rotman the fire department made note of this but never sent anyone to thier residence to check the car that Shay had done the repair work on and brought back to the Rotman's.

Since the bombing (10/28/91) the Rotman's have not experienced any disturbances nor have they recieved threats of any kind. Mrs. Rotman went on to say that her and her husband live very clean lives and have had no problems within their social life or their business ventures over the years. Mrs. Rotman concluded by stating that not in her wildest imagination would she know of anybody who would want to harm either herself or Mr. Rotman.
