9. DETAILS:

This report pertains to the investigation on the bombing that occurred at the residence of Thomas Shay Sr., 39 Eastbourne St., Roslindale, Massachusetts in which a Boston Police Bomb Squad member was killed and another critically injured. ATF, in conjunction with the Boston Police Homicide Unit, is currently investigating this incident.

On December 5, 1991 Special Agent Dennis Leahy and Special Agent Thomas D'Ambrosio received from William McNamara, Broadcast Center, Tel. No. 450-7013, ext. 7013, wood fragments and pieces of black electrical tape from the roof of the First Church of Christ Scientist Building.

These items are remnants of communications work performed at the above location by a suspect in this investigation.

This report will serve to transmit exhibits 63 and 64 to the lab and to request that all pertinent forensic analysis be conducted.
