Report of Interview

With David Hanbury, on January 26, 1992 at approximately 1:30 PM., at Roy Rogers Restaurant, Route 128, Needham, Massachusetts, by AUSA Paul Kelley, ATF Supervisor Victor D. Palaza and ATF Special Agent Jeff S. Kerr. Mr. Hanbury stated as follows:

Mr. Hanbury stated that his date of birth is August 11, 1974 and his social security number is [redacted]. He stated that he resides at the residence of his parents, 69 Parkinson Street, Needham, Massachusetts, 02192. He stated that he is a student at Needham High School, currently in his junior year.

Hanbury stated that he met an individual named Russell Bonanno through a tele-conferencing network which is computer accessible. He stated that he developed a friendship with Bonanno and that Bonanno introduced him to an individual named Thomas A. Shay. He stated that his introduction to Shay was made on or about September 21, 1991 via the telephone. He stated that Bonanno suggested the introduction subsequent to his (Hanbury's) request for information relative to an organization called B.A.G.L.Y, (Bisexual Alliance of Gay and Lesbian Youths). Hanbury stated that Bonanno had informed him that Thomas Shay had attended B.A.G.L.Y meetings.

Hanbury stated that on or about September 22, 1991 Shay telephoned to tell him about a fight that he (Shay) had with Bonanno. Hanbury stated that Shay informed him that the fight was over Shay's desire to have pets at the house which he was staying, that being Russell Bonanno's residence in Dartmouth, Massachusetts.

DETAILS (Continued)

Hanbury stated that he first met Shay sometime during the last weekend of September. He stated that Bonanno picked him up in his (Bonanno's) personal vehicle and drove with him to pick up Shay in Quincy, Ma. He stated that when they arrived at Bonanno's residence he and Shay became engaged in conversation. He stated that Bonanno became very agitated at Shay because he felt that Shay was lying about a number of issues. He stated that Bonanno and Shay had words with each other and that Shay became destructive, throwing a few items around the house. He stated that Bonanno decided that he was going to take Shay and him (Hanbury) back to their respective residences.

Hanbury stated that Bonanno drove first to Shay's mother's residence in Quincy, Ma. and that Shay asked them to wait a couple of minutes. He stated that Shay returned out of the house and requested that he be driven to a hospital because he was very depressed. Hanbury stated that he and Bonanno drove Shay to a hospital but when they arrived at the hospital Shay changed his mind. He stated that Shay then requested to be driven to a friend's home. He stated that approximately four times Shay was driven to locations that Shay described as the homes of friends. He stated that each time Shay was dropped off at a friend's home he would return shortly thereafter informing Bonanno and Hanbury that the friend was not at home.

Hanbury stated that after Shay's unsuccessful attempts to locate a friend, Shay decided that he wanted to go to a bar and that he was then driven to the Ramrod, a bar located in the Fenway Park area of Boston. He stated that it appeared that Shay was trying to get picked up and that at one point, he asked to be dropped off in the street. He stated that he talked Shay into returning to his (Shay's) mother's residence. He stated that it was some time during this night that Shay requested his address and phone number.

Hanbury stated that he had no other face to face meetings with Shay. He stated that he received one letter from Shay on or about November 16, 1991 and that he did not write a letter to Shay at any time.

Hanbury stated that on or about January 3, 1992 he received a telephone call from Shay. He stated that during this conversation Shay told him that he had acquired the services of an attorney and that they were going to telephone every individual listed in Shay's address book to determine if these people had experienced any sort of harassment from the police. He stated that Shay explained to him that he may be contacted by the FBI. He stated that Shay placed an individual on the telephone who claimed to be a District Attorney. He stated that he did not remember the name of the man whom he spoke with.

Hanbury stated that on or about January 4, 1992 he received a telephone call from the same man who claimed to be a District Attorney and that the

man informed him that Shay would be filing a Civil Liberties violation suit against the police.

Hanbury stated that on this same day he received a telephone call from Shay. He stated that Shay had said that he (Shay) was being framed for the bombing incident at his father's residence. He stated that Shay told him during this conversation that he was with FBI agents. He stated that he asked Shay to speak with the agents but that Shay denied his request. He stated that this was the last time he spoke with Shay.

Hanbury stated that on or about January 7, 1992 he received a telephone call from a male who claimed to be the senior editor for a magazine called "Out" or possibly "Outweek". The individual asked him to relay his (Hanbury's) encounters with the police. Hanbury stated that he described to the man how the Boston Police had telephoned his residence and left a message on his father's answering machine. He stated that he intercepted the message and telephoned a police officer who's name he could not recall. He stated that he was upset that this call had jeopardized his desire at that time to not "come out" with regards to his gay life style.

Hanbury stated that Shay had told him that his (Shay's) sisters were "bitches". He stated that Shay had told him that a boyfriend of his (Shay's) had been killed by gay-bashers in Boston. He stated that Shay told him that the people who killed this boyfriend were the sons of high ranking Boston officials and that these men were not prosecuted. He stated that Shay told him that the gay-bashers had run over his boyfriend with a truck.
