I HAD ARRIVED AT WHITEAWAY AVE AFTER BEING REQUESTED  
TO LEAVE JOHN CATES 133 ATLANTIC STREET QUINCY ADDRESS  
BY AGENT ~~THE~~ JEFF KERR, <sup>AND THAT MY FATHER HAD TO LEAVE AND WANTED ME</sup> WHEN I ARRIVED AT WHITEAWAY  
AVE I ~~NOTICED~~ HAD PARKED MY CAR AT THE END OF MY

WHEN THEY HAD FINISHED THIS AND I CLOSED MY TRUNK AND DRIVERS DOOR DENNIS LEAHY ASKED HOW MY BUSINESS WAS GOING. I SAID THAT MY FORMER BUSINESS PARTNER, RICH BROWN, WAS HEAVY INTO COCAINE AS WELL AS HIS GIRLFRIEND AND THAT RICH BROWN WAS NOT PAYING ME FOR ALL THE WORK I HAD DONE AND THAT RICH BROWN WAS BOUNCING CHECKS ALL OVER THE PLACE (FROM THE COMPANY'S BUSINESS ACCOUNT). I TOLD HIM THAT I HAD A NEW BUSINESS PARTNER, A GREEK FROM HULL. AT AROUND THIS TIME MY PAGER HAD GONE OFF, I THINK IT WAS VASILIANIS TASSO, AND I PICKED UP MY CELLULAR PHONE AND MADE THE CALL. ABOUT TWO MINUTES INTO THE CALL MY PHONE WENT DEAD. \*② I ASKED IF I COULD USE DENNIS LEAHY'S CELLULAR PHONE AND HE SAID YES. I MADE MY CALL ON DENNIS LEAHY'S CELLULAR PHONE, FINISHED, \*① AND THEN DENNIS LEAHY ASKED ME TO COME TOWARD THE GARAGE TO LOOK AT SOME THINGS. I WAS SHOWN A CARDBOARD BOX THAT HAD A WINE BOTTLE, A BUNCH OF CANS, A GREY PORON JAR WITH A COVER AND A WICK COMING OUT OF IT. I TOLD THEM THAT IT LOOKED AS IF MOST OF THE THINGS THAT THEY WERE TAKING BELONGED TO MY BROTHER DAVID. I NOTICED A FEW CANS OF PAINT (CANS AND SPRAY CANS) AND COMMENTED THAT THESE BELONGED TO MY BROTHER BECAUSE HE DID A LOT OF PAINTING AND FURNITURE BUILDING. \*③ ONE OF THE AGENTS CAME UP TO ME WITH A GREY PAINTED BOX WITH A HOLE IN ONE OF THE SIDES. HE ASKED ME IF I KNEW WHAT IT WAS I SAID THAT I DIDN'T KNOW AND THAT IT ALSO WAS MY BROTHER DAVID'S AND THAT THEY SHOULD ASK HIM ABOUT IT.

DENNIS LEAHY THEN ASKED ME ABOUT THE SO DEVICE  
AND I SAID IT WAS PUBLIC KNOWLEDGE THAT IT WAS  
A TANK OR FLASH SIMULATOR THAT WAS JUST LIKE AN  
M-SO EXCEPT THAT IT HAD A COUPLE OF WIRES COMING  
OUT OF IT AND THAT DONNA SHEA HAD BEEN TOLD THAT  
12 VOLTS ATTACHED TO THESE WIRES WOULD CAUSE IT TO  
GO OFF. I SAID THAT IT HAD WHAT I ASSUMED TO ~~NAME~~

NOT ACCIDENTLY GO OFF. DENNIS LEAHY THEN ASKED ME  
WHAT I KNEW ABOUT BLASTING CARS AND I SAID THAT I  
DID NOT KNOW ANYTHING ABOUT THEM EXCEPT THAT WHENEVER  
I WOULD DRIVE BY <sup>SOME</sup> CONSTRUCTION SITES THERE WOULD BE  
SIGNS TO TURN OFF ALL TWO WAY RADIOS BECAUSE OF BLASTING  
IN PROGRESS AND THAT I ASSUMED THAT WAS BECAUSE  
A LONG WIRES COULD ACT AS AN ANTENNA THAT COULD  
ACCIDENTLY SET OFF AN EXPLOSION. DENNIS LEAHY THEN  
ASKED ME WHAT I WOULD THINK WOULD HAPPEN IF  
DYNAMITE WAS ~~HEARD~~ <sup>EXPLODED</sup> ~~BETWEEN~~ NEXT TO OTHER DYNAMITE  
AND I SAID THAT SINCE, <sup>"</sup>PHYSICS IS PHYSICS I WOULD SAY  
IT WOULD SET THE OTHER DYNAMITE OFF. <sup>"</sup> DENNIS LEAHY  
ASKED ME HOW I KNEW ABOUT DYNAMITE AND I SAID THAT

OTHER THAN REMOTE CONTROL, COULD THIS OCT 28 BOMB

TOLD ME THAT IT WAS RUMORED THAT A ROOKIE FEMALE  
COP KEPT HER MICROPHONE AND THIS IS WHAT MIGHT HAVE  
SET OFF THE BOMB."

I SAID THAT, "A CHEAP REMOTE CONTROL WOULD PROBABLY BE SUSCEPTIBLE TO INTERFERENCE LIKE A TOY CAR THAT'S SUPPOSED TO TURN BY REMOTE CONTROL THAT TURNS BY ITSELF."

DENNIS LEAHY THEN ASKED IF I HAD EVER GONE TO THE RADIO SHACK ON MASS AVE AND I SAID THAT I HAVE BEEN THERE SEVERAL TIMES AND THAT I WOULD GIVE THE LAST FOUR NUMBERS OF MY PAGER AS THE CONTROL NUMBER ON THE RADIO SHACK RECEIPT FORM.

LEAHY THEN ASKED IF I HAD SEEN TOM SHAY (JR) RECENTLY AND I SAID THAT SHAY HAD TRIED TO PAGE ME ABOUT TWO WEEKS AGO BUT I DID NOT CALL HIM BACK. I THEN SAID THAT JOHN CATES HAD BUMPED INTO TOM SHAY (JR) ON BOYLSTON ST, BOSTON, AND THAT SHAY RECOGNIZED JOHN CATES AND THAT (JR) STARTED TO LOOK THROUGH HIS ADDRESS BOOK FOR JOHN CATES' NAME AND THAT JOHN CATES TOLD SHAY (JR) THAT HE WAS NOT IN HIS "BOOK" AND THAT HE (SHAY) HAD CAUSED HIM (CATES) AND HIS (CATES) FRIENDS A LOT OF TROUBLE. ALSO THAT SHAY (JR) LAUGHED AND SAID THAT THE POLICE WERE NOT ON THE RIGHT TRACK. I THEN REPEATED WHAT I HAD ~~SAID~~ SAID BEFORE, THAT I HAD MET THE HID (SHAY) AND GIVEN HIM RIDES ON DIFFERENT OCCASIONS, ONCE TO HIS FATHERS HOUSE IN DORCHESTER. DENNIS LEAHY THEN ASKED ME WHAT MY THEORY WAS ON THIS CASE AND I SAID, JUDGING ON THE MEDIA, THAT EITHER THE GUYS FROM WHERE SHAY (SR) WORKED DID IT OR THAT SHAY (JR) MIGHT HAVE DONE IT. I THEN SAID TO DENNIS LEAHY, "YOU KEEP ON TELLING ME IF I HAVE NOTHING TO DO WITH THIS CASE

THAT I HAVE NOTHING TO WORRY ABOUT, AND THERE YOU ARE WITH SEARCH WARRANTS. WHAT CONCERNS ME IS THAT THE FEDS ARE TRYING TO FABRICATE SOMETHING AGAINST ME" (AT THIS POINT IN TIME I DID NOT KNOW ~~WHO~~ WHO WAS A FEDERAL AGENT OR WHO WAS A BOSTON POLICE OFFICER)

- \* ③ I SAID TO LEAHY THAT MY BROTHER MIGHT HAVE GUN POWDER IN THE GARAGE AND THIS CONCERNED ME. DENNIS THEN SAID THAT THEY HAD ALREADY FOUND IT AND DID NOT CARE ABOUT GUN POWDER BECAUSE THAT WAS NOT WHAT THEY WERE LOOKING FOR.
- \* ① AFTER I HAD FINISHED MY CALL ON DENNIS LEAHY'S PHONE I WENT BACK TO MY CAR. A COUPLE OF MINUTES LATER PETER O'MALLEY PULLED UP ON CANTON AVE AND WALKED UP TO ME. AS SOON AS HE HAD APPROACHED ME DENNIS LEAHY AND DET FOGERTY PULLED HIM ASIDE AND I ASSUME TOLD HIM TO LEAVE, PETER O'MALLEY GIVING ME EVIL STARES. PETER O'MALLEY THEN LEFT SCREAMING AWAY IN HIS CAR.
- \* ② DENNIS LEAHY, SEEING MY CELLULAR PHONE, ASKED ME WHAT I HAD IT FOR. I TOLD HIM BECAUSE I WAS TRYING TO LAND A CONTRACT WITH THE NIGERIAN GOVERNMENT FOR SOME SUB-CONTRACT WORK AND THIS WAS THE ONLY WAY MY CONTACT COULD REACH ME 24 HOURS A DAY. I TOLD HIM IT WAS A RENTAL AND IT COSTS ME A DOLLAR A MINUTE FOR INCOMING AND OUTGOING PHONE CALLS.
