REPORT OF INTERVIEW

With Louis and Roslyn Rotman on February 19, 1992 at the Beth Israel Hospital, Boston, Massachusetts by Special Agent Henry J. Moniz, Jr., Bureau of Alcohol, Tobacco & Firearms. Mr. & Mrs. Rotman stated as follows:

They own and operate the Clothes Quarters store located at 340 Main Street, Randolph, Massachusetts, tel. 617-963-6575. Their business is the retail sale of women's clothing and the repair of same. They get ninety percent (90%) of their merchandise outside the state of Massachusetts and the remaining ten (10%) percent from within the state.

They stated they became aware of Thomas Shay, Sr., approximately five (5) years ago when they were looking for someone to repaint their car. Shay, Sr. was recommended by some of the Rotman's customers and his son-in-law, Peter Levitt. As a result the Rotman's eventually hired Shay, Sr. to paint their car.

Sometime during the later part of July, 1991 or the beginning of August, 1991 Thomas Shay, Sr., sent Mr. & Mrs. Rotman a notice that he had relocated his place of business. Mr. Rotman stated he gave the notice he received from Shay, Sr. to a Boston police detective

when they contacted shortly after the bombing incident, 10-28-91. The Rotman's vehicle was subsequently damaged in front of their place of business, Clothes Quarter, Sudbury Plaza parking lot 340 Main Street, Randolph.

On or about October 19, 1991 Mr. Rotman telephoned Shay, Sr., and made arrangements for him (Shay, Sr.) to inspect the damage to his vehicle. Mr. Rotman and Shay, Sr. met at the Howard Johnson's on Route 138 where Shay, Sr. agreed to repair Mr. Rotman's vehicle. The following Monday (10-21-91) Mr. Rotman brought his vehicle to Shay, Sr.'s place of business on Washington Street, in Dedham, for the repair work. At this location Shay, Sr. loaned Mr. Rotman a 1986 Buick, 4 door century black in color bearing Massachusetts registration 125LLO.

Mr. & Mrs. Rotman had the loaner vehicle for approximately ten (10) days. The Rotman's stated they used this vehicle in their private lives and the conduct of their business. They said the loaner vehicle was not in good shape and they did not feel as though they could depend on it. While they did have this vehicle they did not leave the state of Massachusetts with it. As to its use in their business they stated they used it primarily to go to and from work.

Mrs. Rotman was totally dissatisfied with Shay, Sr.'s loaner vehicle and had Mr. Rotman telephone him (Shay, Sr.) for the return of their vehicle. Shay, Sr. agreed to deliver the Rotman vehicle on Friday (10-25-91, to the best of Mr. Rotman's knowledge and belief as to the date) to their place of business in the Sudbury Plaza, 340 Main Street, Randolph, which he did. When Shay, Sr. arrived with Rotman's vehicle Mr. Rotman accepted its delivery. At that point Mr. Rotman returned the loaner to Shay, Sr.

That same day Mrs. Rotman noticed a defect in the repair work of their car. The following day Mr. Rotman telephoned Shay, Sr. to notify him of the defect in his work. Mr. Rotman stated that Shay, Sr. was upset that he (Rotman) was not satisfied with his work but agreed to correct the defect.

Mr. & Mrs. Rotman stated the only persons who knew they had a loaner from Shay, Sr. were their children and Shay, Sr.
