9. DETAILS:

Report of Interview

With Richard Brown on February 25, 1992, at 3:00PM in Weymouth, Massachusetts, by Special Agent's Thomas E. D'Ambrosio and Jeff S. Kerr, Bureau of Alcohol, Tobacco and Firearms.

Mr. Brown states as follows:

Richard Brown stated that in conjunction with ARCOMM's work at the Christian Science Broadcasting Center, at any time there were a variety of people employed by ARCOMM at the site. Mr. Brown was shown photographs that were taken at the site on the day that ARCOMM utilized a helicopter to lift equipment to the roof. Brown identified the people in the photograph from left to right as:

1. Keith LNU, pilot employed by Wiggins Airways.
2. John Ryder, pilot employed by Wiggins Airways.
3. Unknown individual, ground crew member employed by Wiggins Airways.
4. Bill McNamara, Christian Science Center employee.
5. Richard Brown.
6. Dwight Brown, Richard Brown's father.
7. Nurdan Cagdas, ARCOMM employee.

Brown also said that on occasion an individual by the name of David Fardy would be working on the site. Brown said that Fardy is employed by The Design Shop, Newton, MA. a sub-contractor on the project. He said that Fardy is a friend of Alfred Trenkler, which led to The Design Shop being hired as a sub-contractor.
